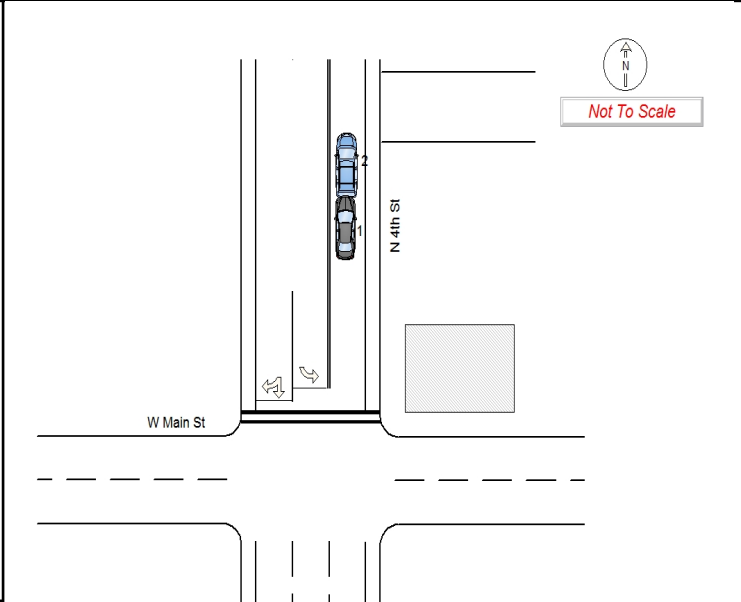

NARRATIVE

Unit 2 was traveling Northbound on N 4th St in slow moving traffic. Unit 1 was also traveling Northbound on N 4th St proceeding through the intersection at W Main St. Unit 2 stopped to allow a vehicle to pull out of a parking lot. As Unit 1 approached Unit 2 he failed to stop in assured clear distance causing a collision. Unit 1 sustained front end damage to his vehicle and Unit 2 rear end damage. Unit 1 was cited for ACDA. No injuries were reported.
