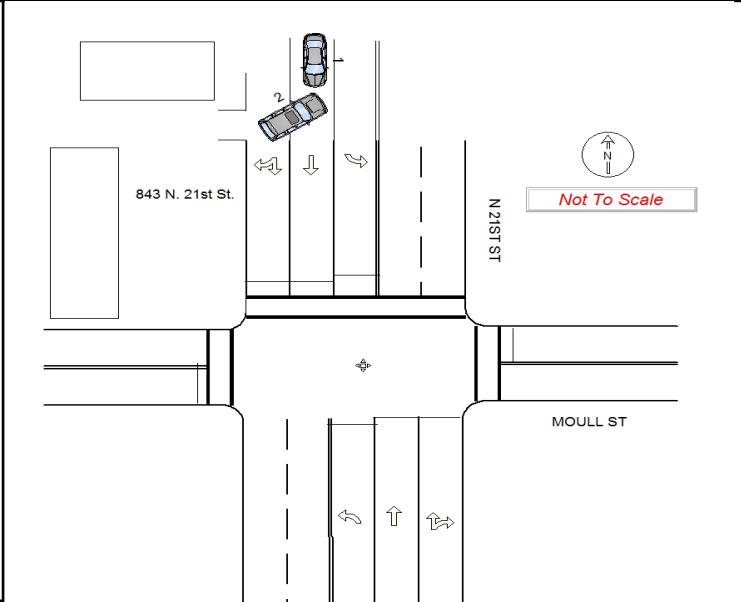

NARRATIVE

Unit 1 was traveling in the left lane s/b on N. 21st St. approaching 843 N. 21st St. Unit 2 was stopped in the parking lot of 843 N. 21st St. waiting to turn n/b onto N. 21st St. A vehicle, in the curb lane, slowed / stopped to allow unit 2 to exit the parking lot to go north on N. 21st St. The driver of unit 1 saw unit 2 pulling out in front of him. The driver of unit 1 attempted to avoid the collision but was unable.

Unit 1 sustained heavy disabling damage to the front of the vehicle. Unit 2 sustained moderate damage but was still functional.

Unit 1 had expired license plates and the driver was issued a citation for the registration. Unit 2 was issued a citation for failure to yield.
