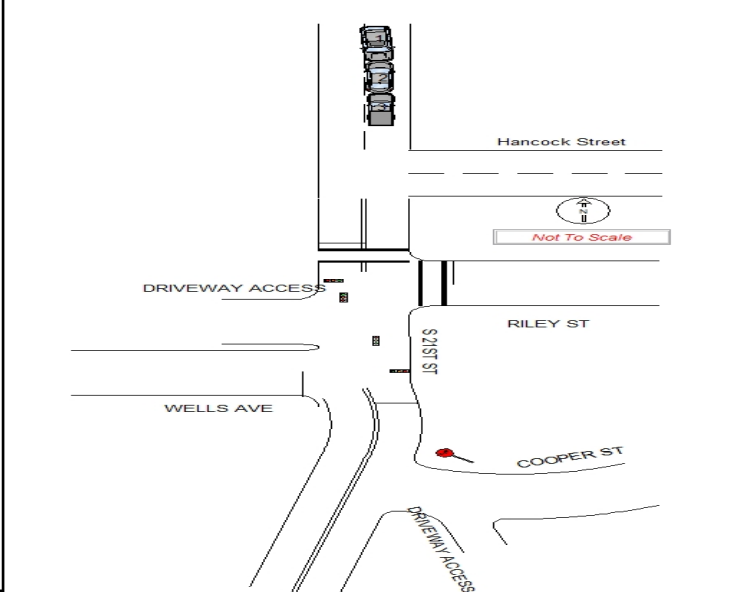

NARRATIVE

Unit 1 was traveling southbound on S. 21st Street approaching Hancock Street. Unit 2 and unit 3 were both traveling northbound on S. 21st Street approaching Hancock Street. The driver of unit 1 whom was fatigued, fell asleep at the wheel and traveled into the northbound lane and struck unit 2 head on. Unit 3 was not able to stop in time due to the accident and struck the rear of unit 2. The driver of unit 1 was cited for driving left of center. The driver of unit 2 was transported to LMH. Both unit 1 and unit 2 were disabled and had to be towed from the scene.
