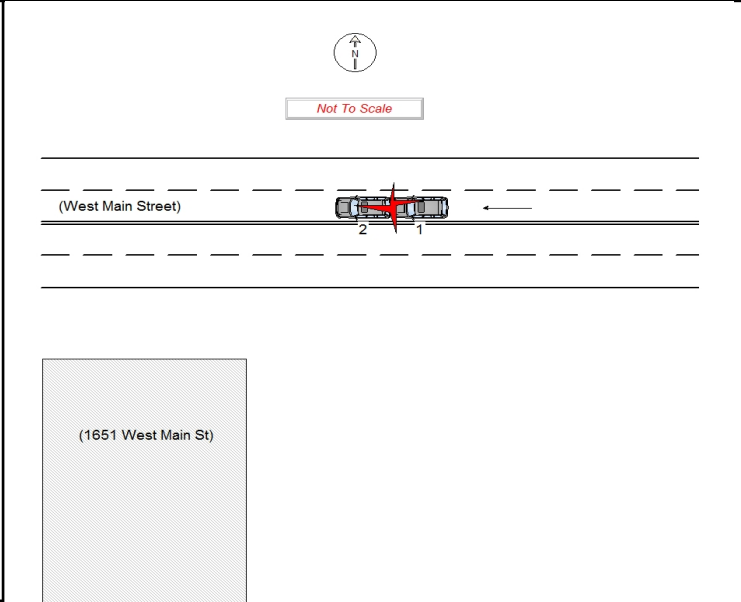

NARRATIVE

10/06/2016, 1530 hours, Unit#02 was traveling West on West Main Street and stopped/slowed in traffic near 1651 West Main Street. Unit#01 was traveling behind Unit#02, in the same lane, and struck Unit#02 in the rear. Unit#01 then left scene of crash citing a medical emergency. No obvious damage to Unit#01 resulted from crash and minor scratches to Unit#02. Multiple witnesses reported Unit#01 operating in a reckless and excessive speed manner prior to and after contact with Unit#02, to include a Police Sgt. Operator of Unit#01 was found and identified and issued a citation for the crash at a near by medical complex.
