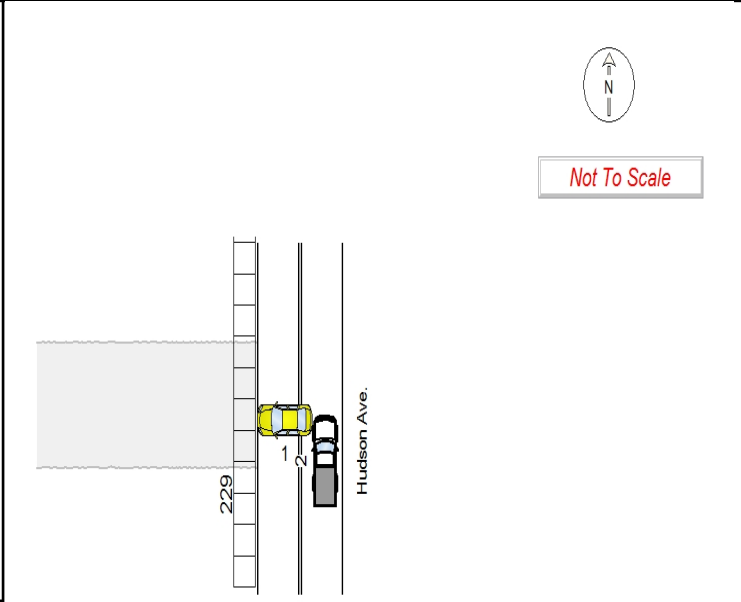

NARRATIVE

I responded to a non-injury accident in the area of 200 Hudson Ave. Upon arrival, I spoke with Paul Negele and Danielle Bishop. Mr. Negele was driving his 2011 Dodge Ram with Ms. Bishop riding as a passenger. I also spoke with a witness William Miller.

Mr. Negele first advised me that he is a license conceal carry and currently has his firearm in his truck. Mr. Negele stated he was traveling northbound on Hudson Ave. when a yellow Chevy Cobalt began to back out of a driveway before entering the roadway and striking the driver side front end of his truck. Mr. Negele stated he got out of his truck and spoke with the male driver. The male driver asked if they were fine. Mr. Negele then asked the male subject if he was leaving and he stated he was not that he was going to pull his vehicle back into the driveway. Mr. Negele began to help push the male subjects vehicle thinking he was putting it back in the drive way but the male subject fled the scene. Mr. Negele photographed the license plate and showed me the photo. He advised the vehicle will have a smashed rear bumper on the driver side as well as a missing taillight. The vehicle's register owner returned to a Lavonda Elliott. Mr. Negele advised that the driver was a white or mixed male.

Ms. Bishop stated she observed a yellow cobalt backing out of a driveway before striking her boyfriend's truck. She stated that Mr. Negele then got out of his truck and spoke with the driver of the cobalt and began pushing the vehicle trying to help the driver put his vehicle back into the driveway but instead he turned and took off.
