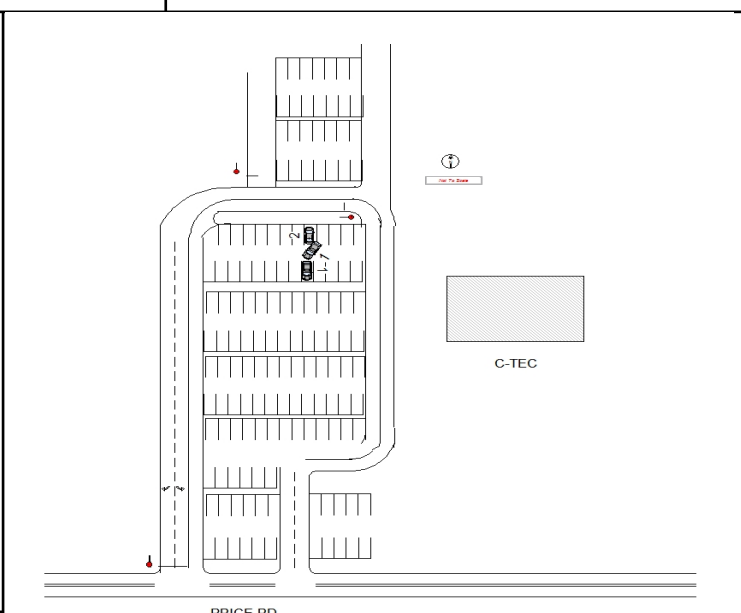
NARRATIVE
