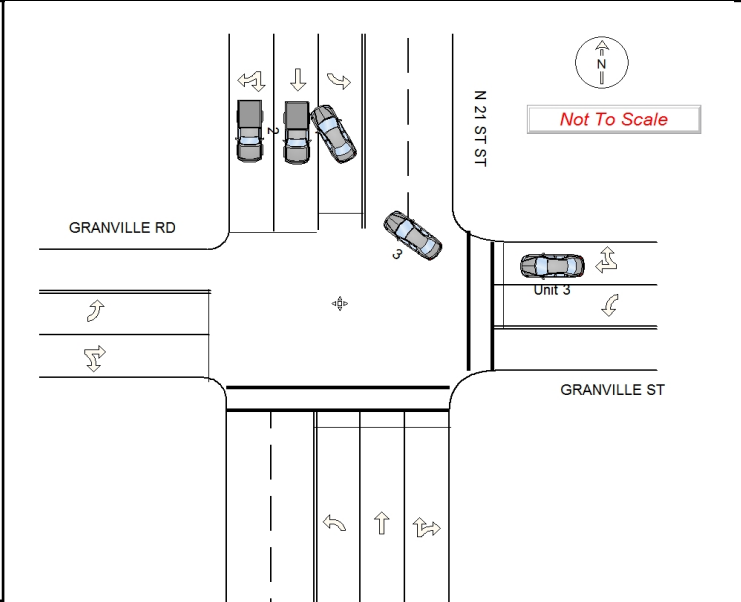
**NARRATIVE**

Unit 1 and 2 were stopped s/b on N. 21st St. at Granville St. for a red light. Unit 3 was traveling w/b on Granville St. Unit 1 was in the left lane and unit 2 was in the right lane.

Unit 3 made a right turn off Granville St. onto N. 21st St. heading n/b. Unit 3 made a wide right turn driving into the N. 21st St. s/b left turn lane. The front left portion of unit 3 struck the rear left portion of unit 1. The rear right portion of unit 1 struck the back driver side door of unit 2.

Unit 1 appeared to sustain moderate damage to both rear left and right side of the vehicle. Unit 2 sustained damage to the left side of the vehicle. Unit 3 sustained heavy damage to the front of the vehicle and both front and side airbags were deployed for the driver seat.

The driver of unit 3 does not remember what happened and is unsure how it happened. The driver of unit 3 stated that she remember driving n/b on N. 21st St. and that was it.
