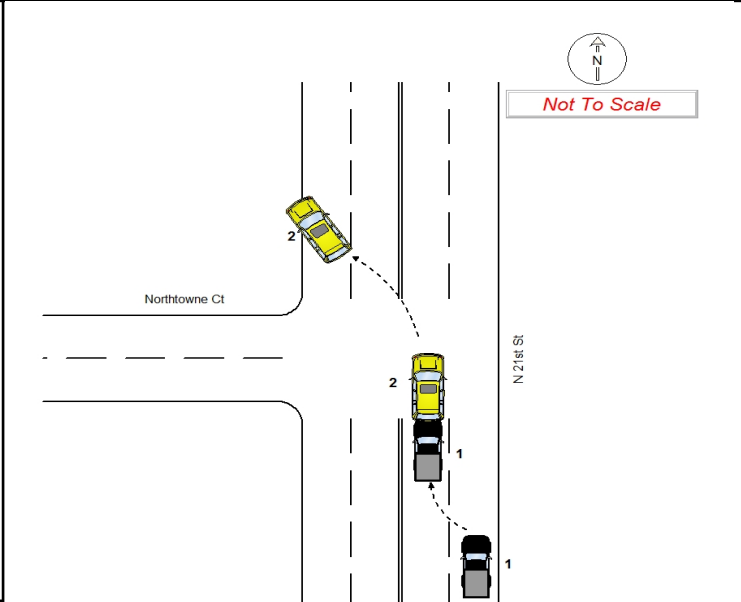

**NARRATIVE**

Unit 1 was traveling Northbound on N 21st St approaching Northtowne Ct in the far right straight lane. Unit 2 was stopped facing Northbound on N 21st St in the inside right hand lane attempting to make a left turn onto Northtowne Ct. Unit 1 attempted to pass the vehicle in front of him on the left when he rear ended Unit 2, pushing her across the road into oncoming traffic. Unit 1 was unable to provide proof of valid insurance and was cited for assured clear distance ahead. Unit 1 was advised to bring proof of insurance with him to pay his citation.

Newark Fire responded to the scene and checked out the driver of Unit 2 but no one was transported to the hospital.

A-one towing responded and took both vehicles from the scene.
