Unit 1 was also traveling Eastbound on W Main St approaching S 35th St where he came to a stop.

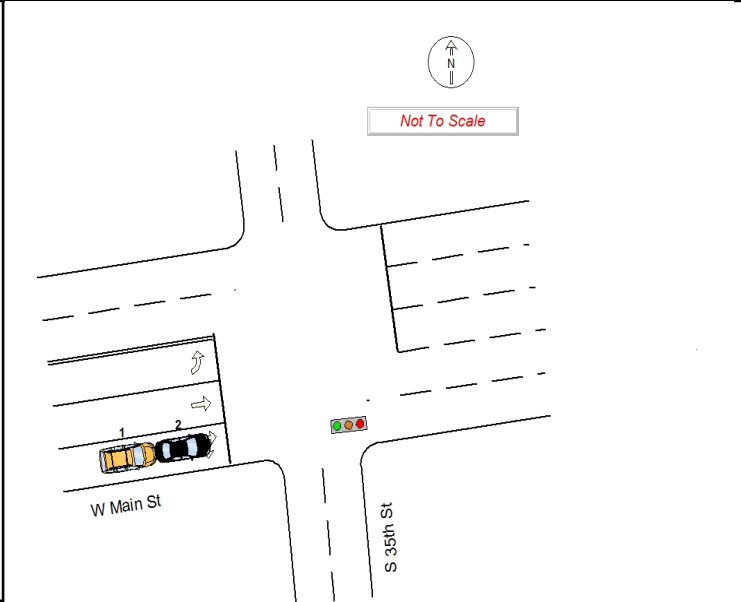
Unit 2 stated the light turned green but he did not go due to an ambulance passing through the intersection with it's emergency lights activated.

Unit 1 stated he was still stopped behind Unit 2 and when the light turned green and the ambulance entered the intersection. Unit 1 stated his foot then slipped off the break and hit the accelerator causing him to collide with the rear end of Unit 2

Unit 2's passenger was taken to LMH by the Newark Fire Department Medic due to neck pain. Unit 2's driver responded to LMH after to also get checked out for neck pain.

There was no noticeable damage besides possibly a few small scratches. Photos were taken of both vehicles at the scene.

Unit 1 was found at fault for this accident.
