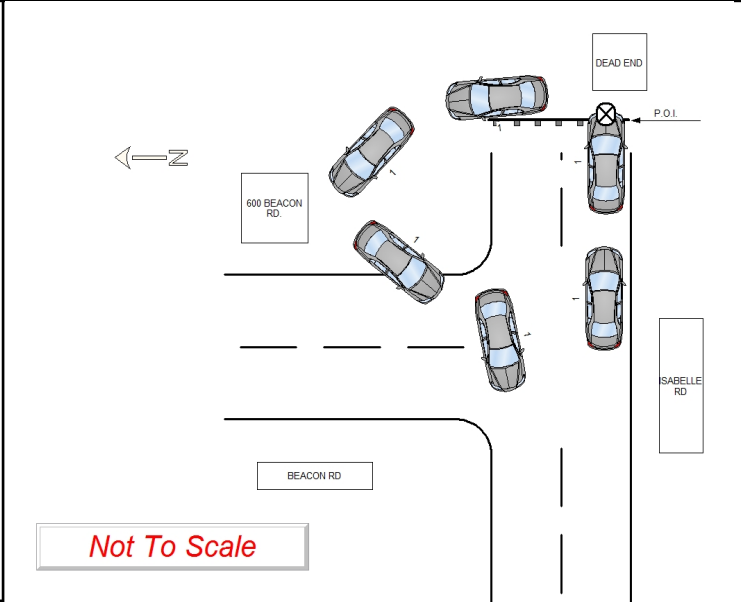

Stated date and time I was dispatched to the dead end section of Isabelle on a hit skip. When I arrived on scene I spoke to Daniel Fortney. Mr. Fortney showed me where someone hit the guard rail at the dead end of Isabelle removing it from the ground. Mr. Fortney then showed me where the vehicle turfed his yard at 600 Beacon Rd, as it drove thru it to get back on the roadway. I found several broken parts of a front grill that I collected for evidence. I checked the area for a vehicle the had front end damage, but could not locate any.

I then spoke with Sgt. Bline who stated that Ofc. J. Phillips was working a hit skip traffic crash that happened on Isabelle Rd. around the same time that this hit skip happened. Sgt. Bline stated that the vehicle, 1985 Dodge 600, had fresh damage on the front of the vehicle that did not match up to the damage from the hit skip Ofc. J. Phillips had, see Ofc. J. Phillips attached OH-1 and statement. Sgt. Bline also stated that the vehicle had mud on it. The vehicle was impounded by Ofc. J. Phillips.

I then took the grill pieces out to the vehicle at the impound lot, to see if they matched up. When I arrived at the impound lot I began to put the pieces of the grill on the vehicle, they matched up. One of the pieces had paint on it and the paint was the same color as the vehicle, see attached pictures. The pieces were then taken off the vehicle and placed into evidence.
