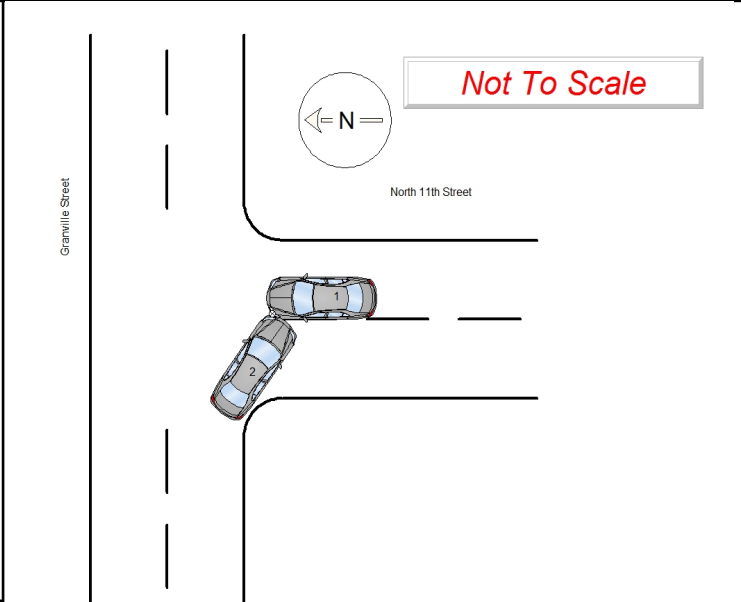

**NARRATIVE**


