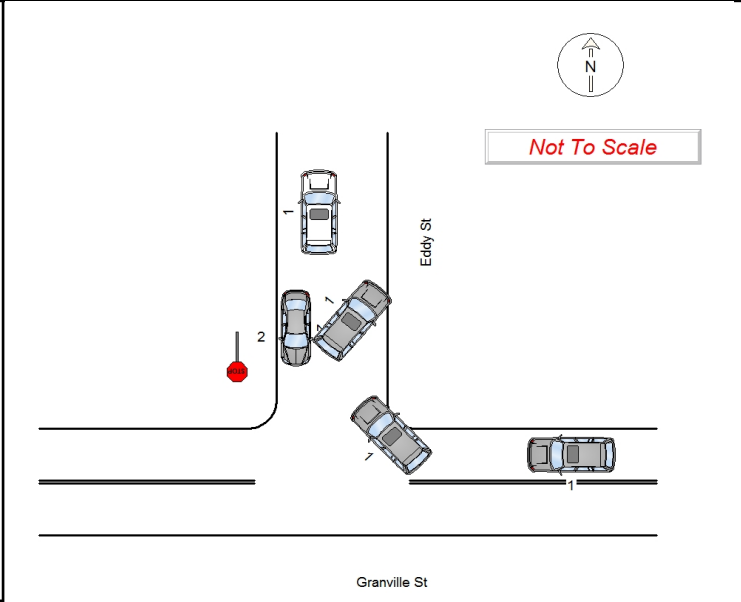

After allowing Unit#2 and his passenger to leave it was later learned while handing Unit#1 her citation she advised that the male was not the driver. I was unable to prove who was driving. I spoke with Driver of Unit#2 which stated that his passenger was not driving. He stated that he had to climb out of the passenger side door because the door would not open. Driver of Unit#1 stated that he just picked her up because she doesn't have a licenses anymore.

Driver of Unit#1 was also given a citation for Non-compliance suspension.
