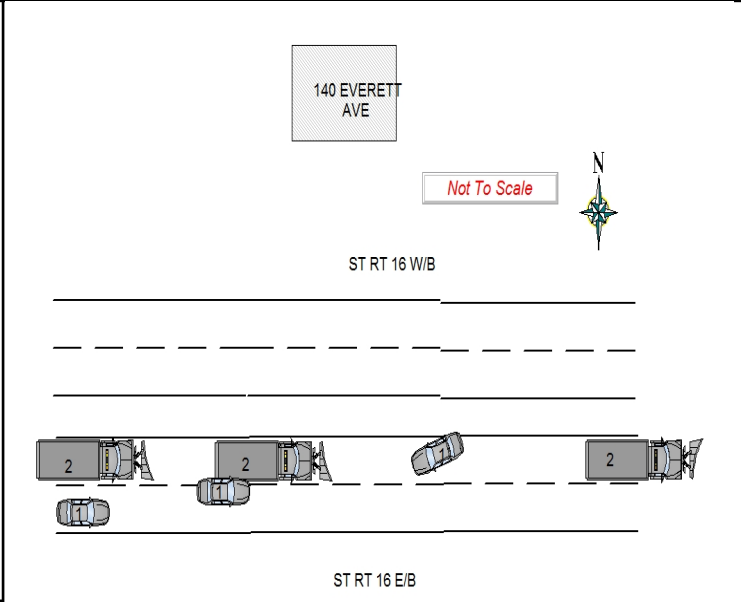

NARRATIVE

Unit#1 stated he was driving East on State Route 16 East bound when he hit a patch of ice and swerved to the right. Unit#1 stated he hit the center divide wall. There was a large hole in the left side passenger door with orange paint transfer. There was a large amount of salt on the road. Unit#1 was the only vehicle at the scene of the accident. I asked Unit#1 if he had hit a plow truck. Unit#1 stated no he did not. There were no plow trucks in the area and this officer was not advised of any plow trucks being hit. The damage to Unit#1 is consistent with the impact of another vehicle, but at this time no other vehicle was made aware to this officer.
