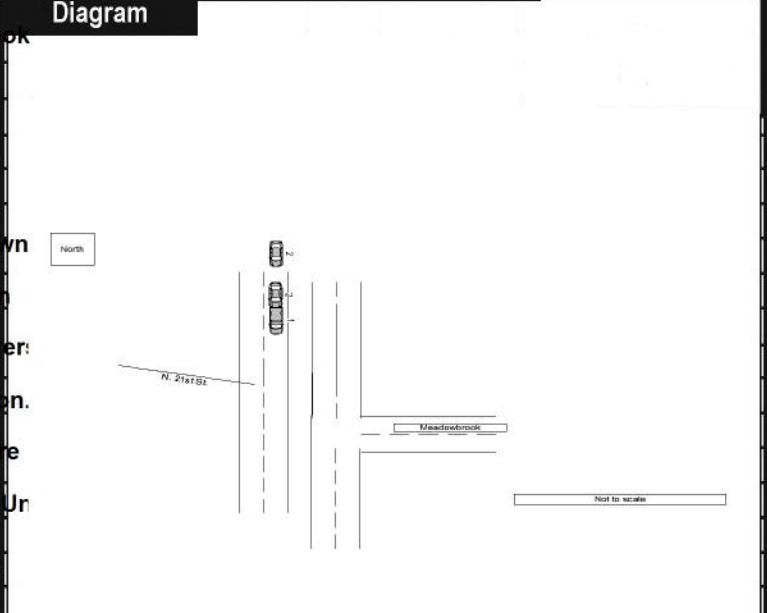

NARRATIVE

Unit 1 was stopped in traffic on N. 21st St., just north of Meadowbrook Dr. Unit 2 was traveling south bound on N. 21st. St. north of Meadowbrook Dr. behind Unit 1. Unit 2 stated that an unknown vehicle/driver pulled from a private lot causing her to swerve and lose her focus. Unit 2 stated she was concentrating on the unknown vehicle which pulled out and not on the stopped traffic. Unit 2 then struck/rear-ended Unit 1 causing damage and injuries to both drivers. Unit 1 was transported for neck pain, and Unit 2 for head contusion. Both Unit drivers were given statements to fill out and return. There are no known witnesses to the crash. Unit 1 was driven away, and Unit 2 towed from scene.


