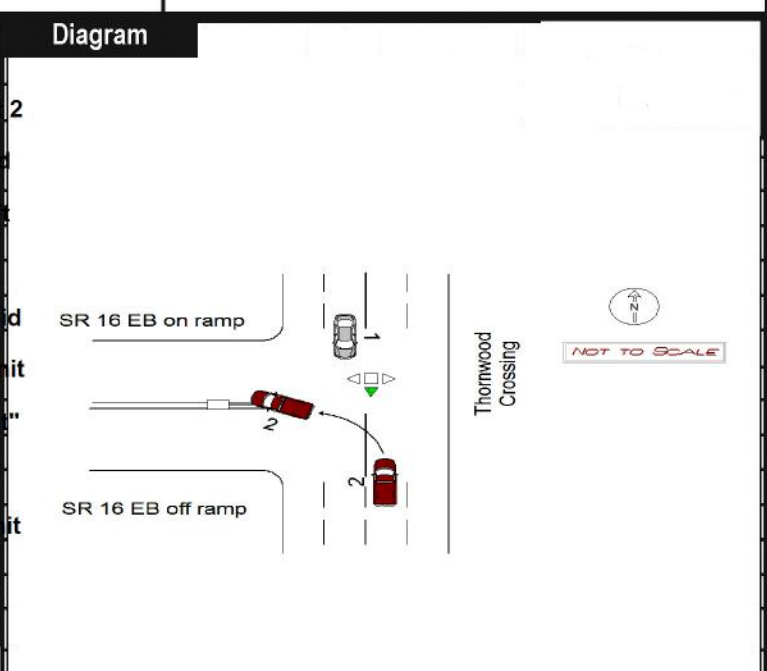

**NARRATIVE**

Unit 2 was northbound on Thornwood Crossing and entering the intersection to make a left hand turn onto the SR 16 EB ramp. Unit 2 had a green light and green left turn signal arrow and therefore had the right of way at the intersection. As Unit 2 began making the left hand turn, Unit 1 failed to yield to their red light and proceeded southbound on Thornwood Crossing into the intersection. To avoid being T-boned, Unit 2 accelerated and cut a hard left hand turn. Unit 2 was able to avoid being struck by Unit 1 but struck a "Keep Right" traffic sign in the process. Unit 1 has no vehicle description and the driver is described as a white female with blonde/white hair. Unit 1 was found at fault and left the scene.




