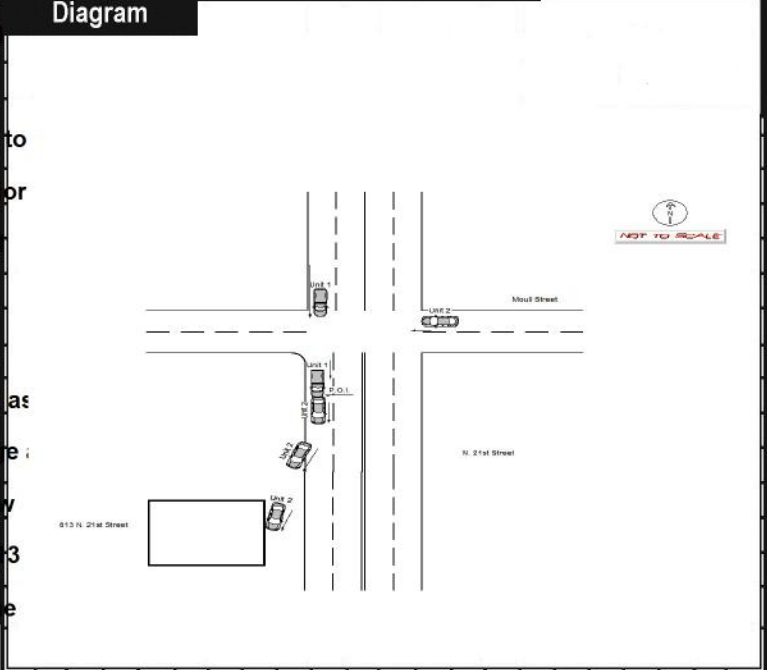

NARRATIVE

Unit 1 travelling s-b on N. 21st St. approaching intersection of Moull St. Unit 2 had right of way (green light), and made left turn from Moull St. s-b onto N. 21st St. Unit 1 driver claimed he looked down to put coffee cup in cup holder then looked up and saw unit 2 just prior to rear ending unit 2. When Unit 1 struck rear of Unit 2, this caused unit 2 to exit off roadway to the right (west side) into yard of residence at 813 N. 21st St. Unit 2 struck house/front railing/shrubbery. Unit 2 sustained damage from being rear ended, as well as from striking house. The building/house did sustain damage; well; shrubbery destroyed, posrch handrail bent, basement window cracked.
