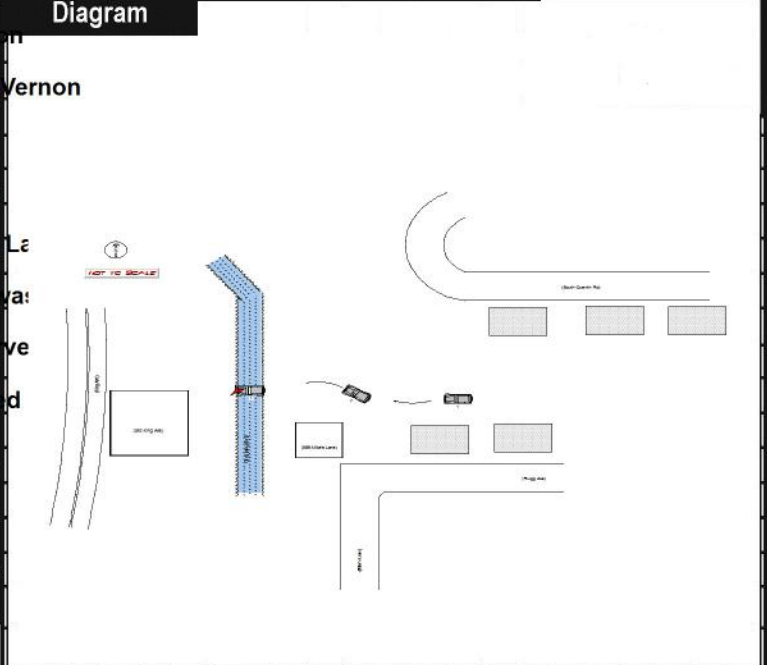

NARRATIVE
06/17/2017, 2050 hours, Unit#01 was driving, west bound, off road, on an un-named Alley between Rugg Ave and S. Quentin Rd, from Mt Vernon Rd. The Alley is not maintained and has only a grass surface. Unit#01 left the grass surface to strike the embankment of the Log Pond Run (creek/river) behind 592 King Rd and west of 589 Mike's Ln. Unit#01 straddled the waterway between the two addresses and was disabled upon impact with the west bank. The operator was observed leaving the crash scene and entering 214 Rugg Ave. Two unopened alcoholic beverages were found in the crash debris.




