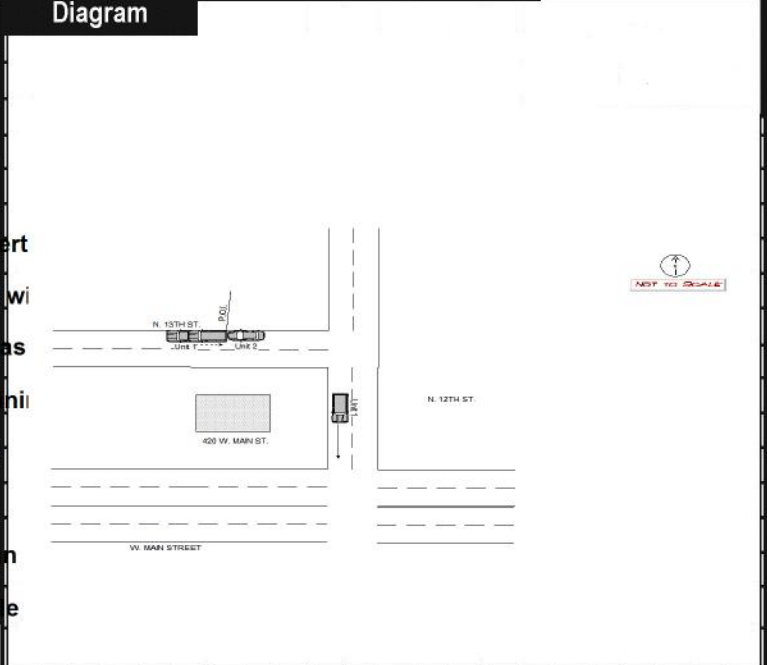

NARRATIVE

Unit 1 parked in front of (west of) Unit 2 on N. 13th Street. Unit 1 backed into Unit 2 at which time his trailer hitch snagged under grill/bumper section of Unit 2. Then Unit 1 drove away with grill section still attached to bumper hitch at his rear. Unit 1 drove to nearby McDonald's parking lot and parked. Owner of Unit 2 was alerted to incident by unknown people in area. Unit 2 owner made contact with Unit 1 driver. Unit 2 owner advised me that he thought the driver was not even aware that the grill was hooked on his hitch. Upon examining Unit 2 lower front bumper, it might be possible that the grill did get snagged on hitch and disengaged without causing extensive damage/noise, especially since Unit 1 is larger /heavier vehicle than Unit 2. Eventually, contact was made with Unit1 driver via phone. He


