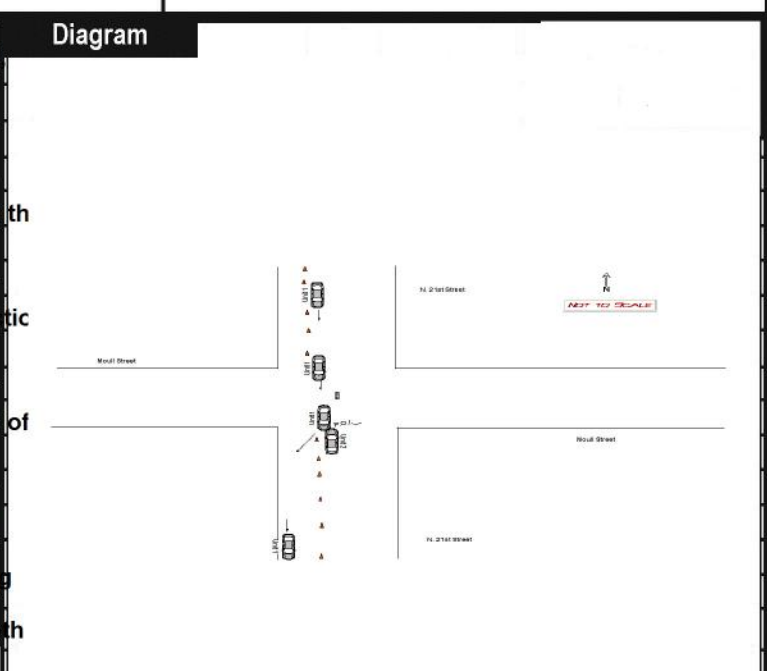

NARRATIVE

Unit 1 traveling S-B on N. 21st Street. Unit 2 was N-B on 21st Street waiting to make left turn, W-B, onto Moull Street, at the intersection. This area of N. 21st Street was in process of being re-paved at time of the accident. Cones had been placed indicating there was one lane of traffic for the S-B traffic. Unit 1 was traveling in the closed S-B lane and as he approached the intersection of 21st St./Moull St. Unit 1 ran the red light and struck Unit 2. Luckily, Unit 1 swerved and narrowly avoided a full head-on strike of Unit 2. Unit 1 left front corner struck Unit 2 left front corner. Unit 1 continued on for about a block, coming to final stop in the right hand (open S-B) lane of 21st Street. As reporting Officer was trying to gather information from occupants/witnesses and document both


