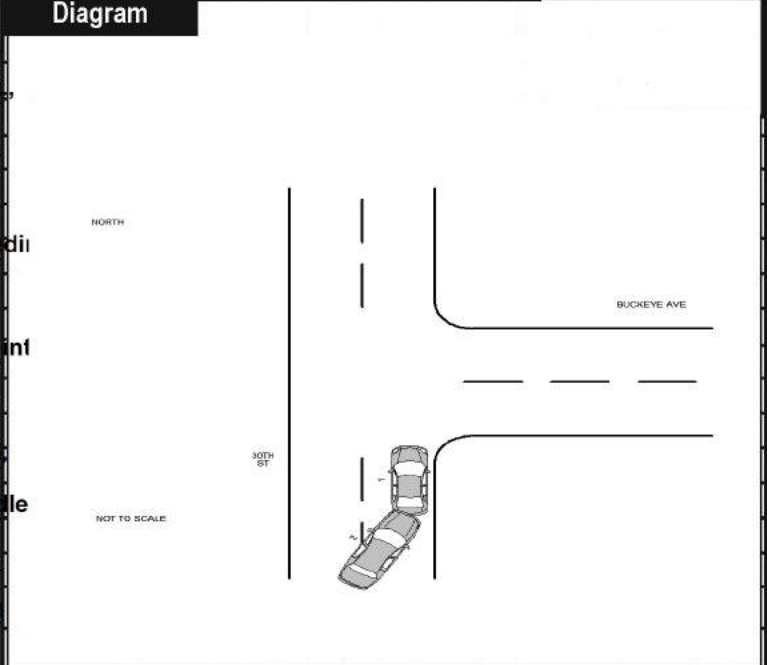

NARRATIVE
Unit 1 was slowed/stopped in traffic traveling north on S. 30th St., just south of Buckeye Ave. Unit 2 was traveling north on S 30th St. at a higher than speed limit in the center turn lane. The driver of Unit 2 reported an on-going domestic violence situation with the passenger-while she drove. Unit 2 driver stated that she was speeding to "get him out the car", during the altercation. Almost the entire domestic incident occurred in the City of Heath, and crossed over into the City of Newark on 30th St. Unit 2 driver stated she was driving in the left center turn lane, when her passenger grabbed the wheel causing her to crash into Unit 1. Heath Police was called and handled the domestic violence incident. All parties reported possible injuries and Newark Fire responded to the scene. The only person

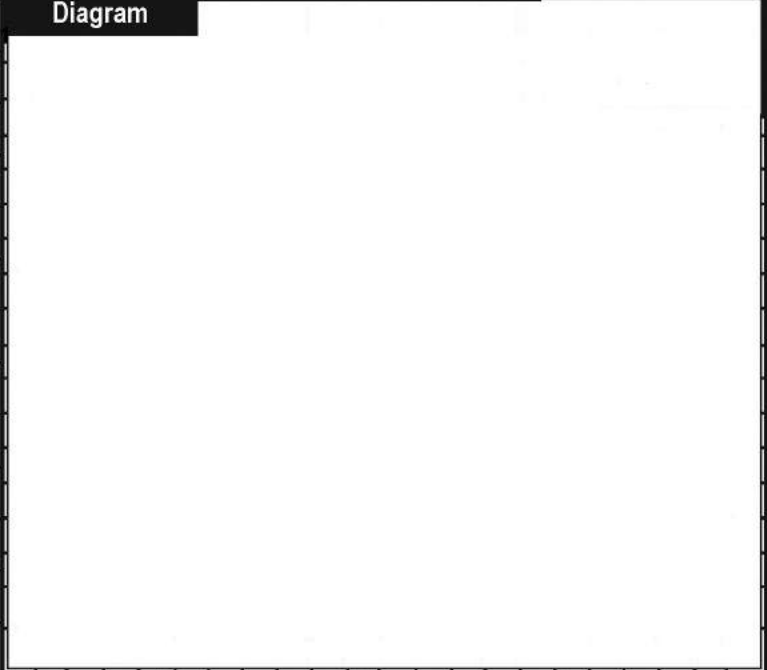
