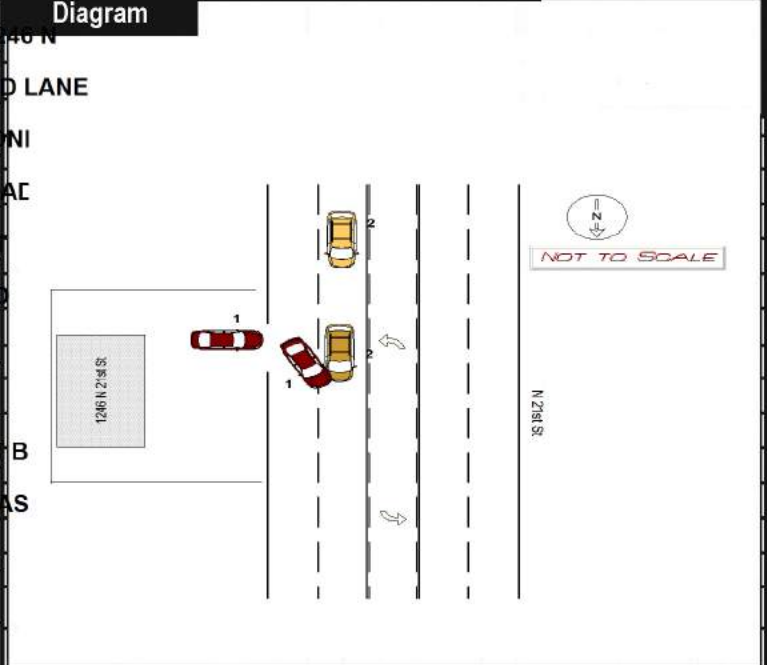

NARRATIVE

UNIT 2 WAS TRAVELING NORTHBOUND ON N 21ST ST PASSING 1246 N 21ST ST WHEN UNIT 1 ATTEMPTED TO ENTER THE NORTHBOUND LANE OF N 21ST ST FROM A PARKING LOT. UNIT 1 ONLY MADE SURE ONE LANE OF TRAVEL WAS STOPPED BEFORE HE ENTERED THE ROAD IN FRONT OF UNIT 2 CAUSING HER TO COLLIDE WITH HIS FRONT END. UNIT 2 SUSTAINED MINOR DAMAGE AND UNIT 1 SUSTAINED DISABLING DAMAGE TO THE FRONT DRIVERSIDE TIRE.

UNIT 2 HAD 2 OCCUPANTS COMPLAIN OF SORENESS FROM SEAT BELT AND THE STEERING WHEEL (UNIT 2 HAD 2 OTHER OCCUPANTS AS WELL). UNIT 1 HAD AN OCCUPANT THAT ALSO COMPLAINED OF SORENESS BUT INJURIES REPORTED.


