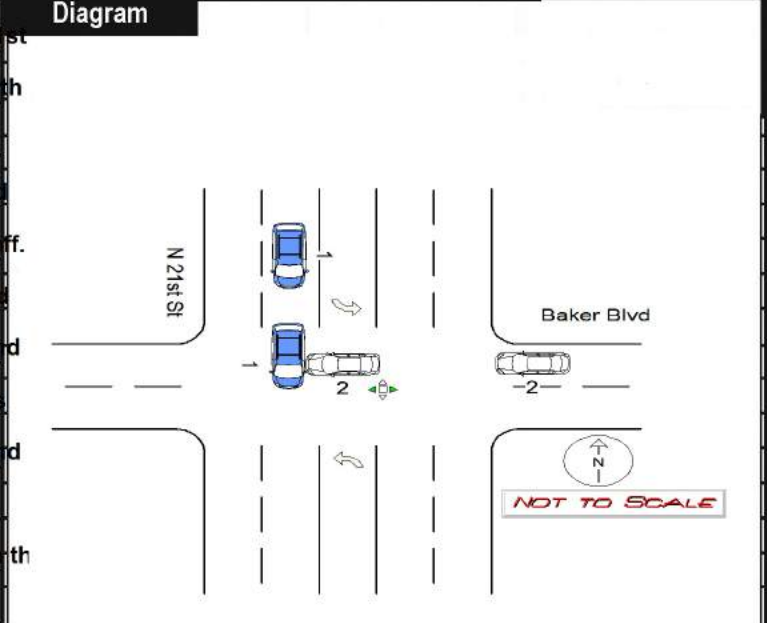

**NARRATIVE**

Unit 2 was on Baker Blvd facing westbound on the east side of N 21st St. Unit 1 was in the inside lane, southbound on N 21st St just north of Baker Blvd. Driver of Unit 1 stated that they "weren't paying attention" to the signal at the intersection of N 21st and Baker Blvd as they were looking farther down the road in preparation to turn off. Unit 1 proceeded through the intersection as the traffic signal had already turned red. Unit 2 proceeded westbound on Baker Blvd and across N 21st St when Unit 1 appeared in front of them. Unit 2 was unable to stop and struck the driver side of Unit 1. Unit 1 was found at fault for failure to comply with a traffic control device. This sequence of events was confirmed by a witness that is included in the report.


