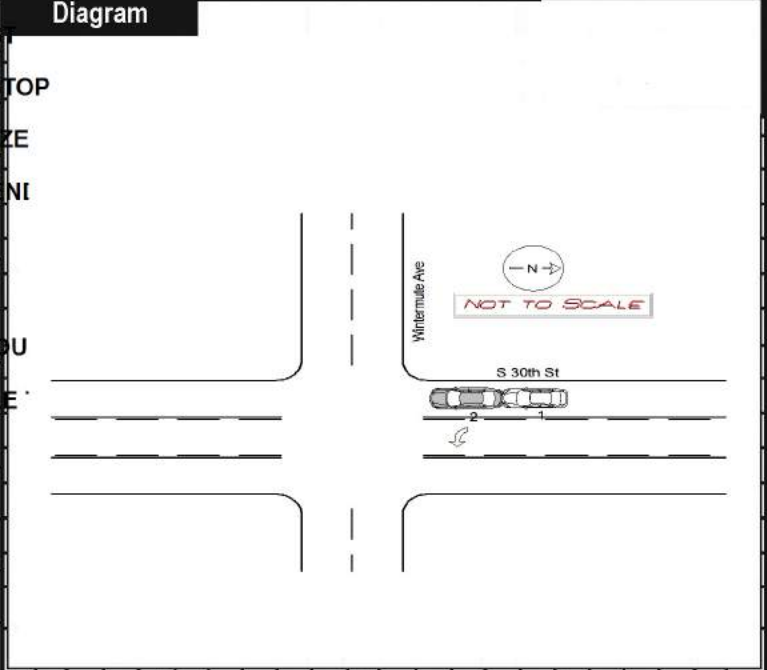

UNIT 1 HAD HEAVY FRONT END DAMAGE AND WAS TOWED BY HOU TOWING. UNIT 2 HAD DAMAGE TO THE REAR END BUT WAS ABLE DRIVE THE VEHICLE AWAY FROM THE SCENE.
