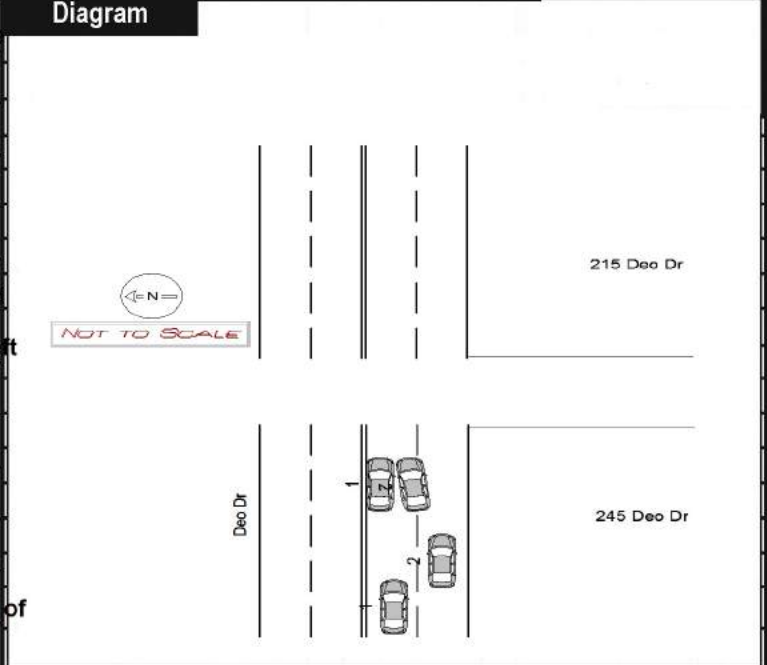
**NARRATIVE**
