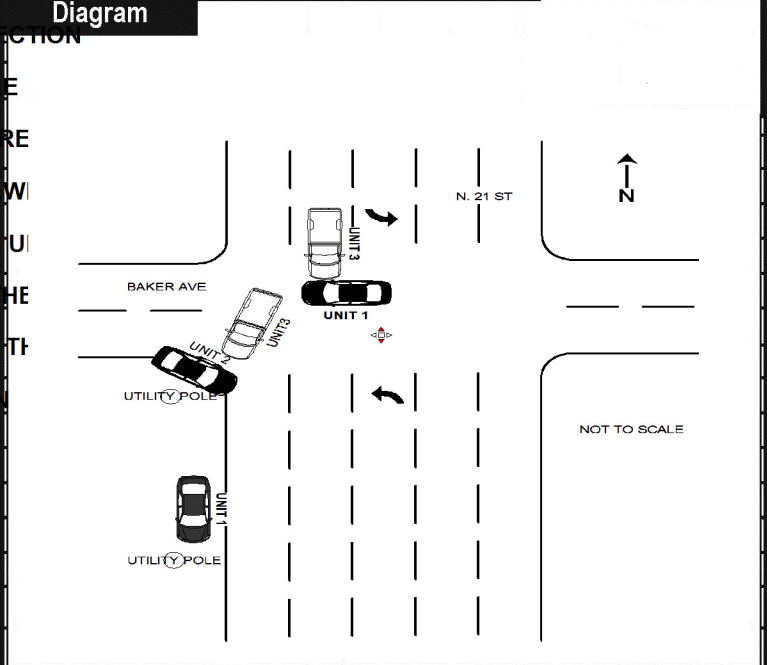

NARRATIVE

UNIT ONE WAS TRAVELING WESTBOUND THROUGH THE INTERSECTION LISTED. ACCORDING TO INDEPENDENT WITNESSES, UNIT THREE WAS DRIVING WITHOUT DUE REGARD AND RAN THROUGH THE RED LIGHT HEADING SOUTHBOUND. UNIT THREE STRUCK UNIT ONE WHICH CAUSED UNIT ONE TO SPIN AROUND AND STRUCK UNIT THREE. UNIT ONE CAME TO REST NEXT TO A POLE ON THE SOUTH SIDE OF THE INTERSECTION. UNIT THREE THEN STRUCK UNIT TWO PUSHING THE VEHICLE INTO POLE WITH A FINAL REST OF BOTH VEHICLES ON THE SOUTHWEST CORNER OF THE INTERSECTION.
