WHEN UNIT #1 REAR ENDED UNIT #2 WHICH WAS TRAVELING AT A

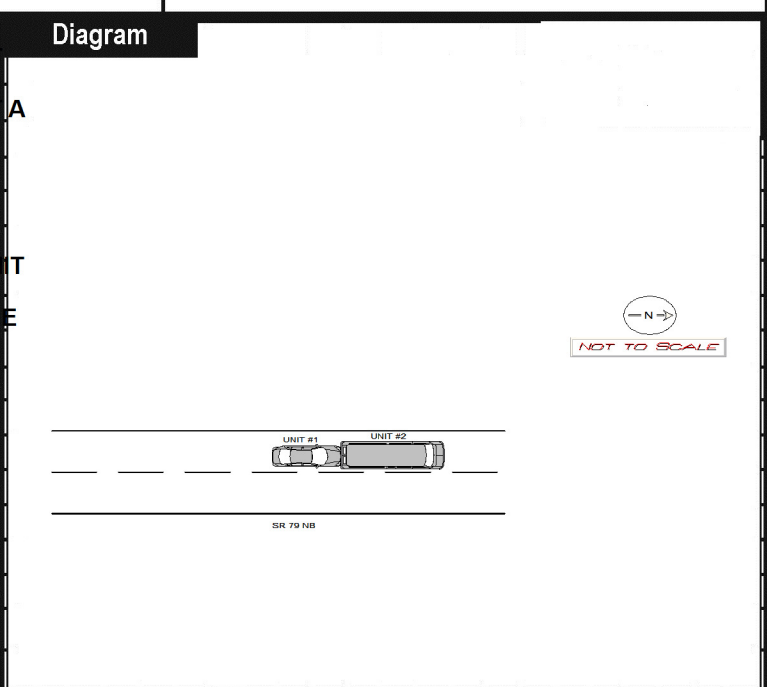
SLOWER RATE OF SPEED THAN UNIT #1 IN THE SAME LANE OF
