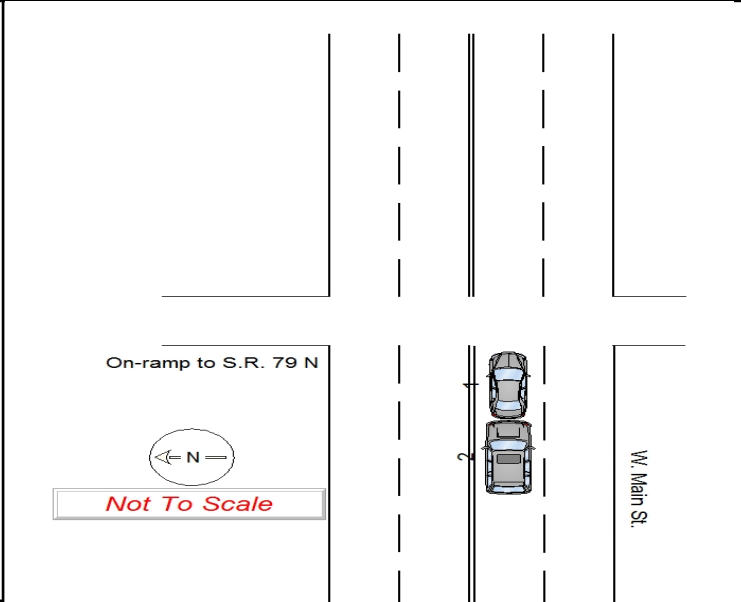

NARRATIVE

Unit 1 and 2 were traveling w/b on W. Main St. at S.R. 79. Unit 1 and 2 pulled into the left turn lane for the on-ramp to S.R. 79 North. Unit 1 was waiting for traffic to clear when unit 2 struck the rear bumper of unit 1.

The driver of unit 1 said that the driver of unit 2 pulled up along side of her and stated that there was no damage. The driver of unit 1 stated that she wanted him to pull over to the side of the road on the on-ramp to S.R. 79 North. The driver of unit 2 stated that he would follow her. The driver of unit 1 pulled onto the on-ramp and pulled over and she watched the driver of unit 2 change lanes and continue e/b on W. Main St.

The driver of unit 1 stated that the vehicle was a a gold or tan Chevrolet Blazer. The driver of unit 1 said that the license plate began with F and ended with 8780 but was unsure of the other two letters. A search through BMV did not show any vehicles matching that description with similar license plates.
