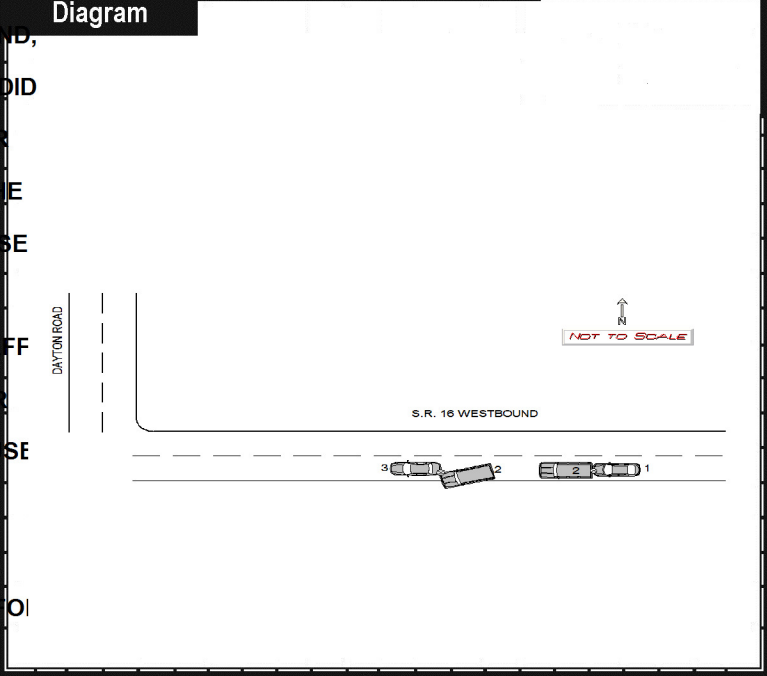

NARRATIVE
UNITS 1 AND 2 STATED THEY WERE TRAVELING SR 16 WESTBOUND, APPROACHING THE LIGHT AT DAYTON RD. UNIT 1 STATED SHE DID NOT STOP IN TIME FOR THE VEHICLES THAT WERE SLOWING OR STOPPED AT THE LIGHT, AND STRUCK UNIT 2. UNIT 2 STATED SHE WAS SLOWING DOWN AND WAS STRUCK BY UNIT 1 WHICH CAUSED TO STRIKE UNIT 3 IN FRONT OF HER. UNIT 3 STATED HE WAS TRAVELING WESTBOUND ON S.R. 16 AND WAS STOPPED IN TRAFFIC AT THE LIGHT. UNIT 3 STATED HE NOTICED UNIT 2 TURNING HER STEERING WHEEL AND WAS HIT FROM BEHIND AND WHICH CAUSED UNIT 2 TO STRIKE HIS VEHICLE.


