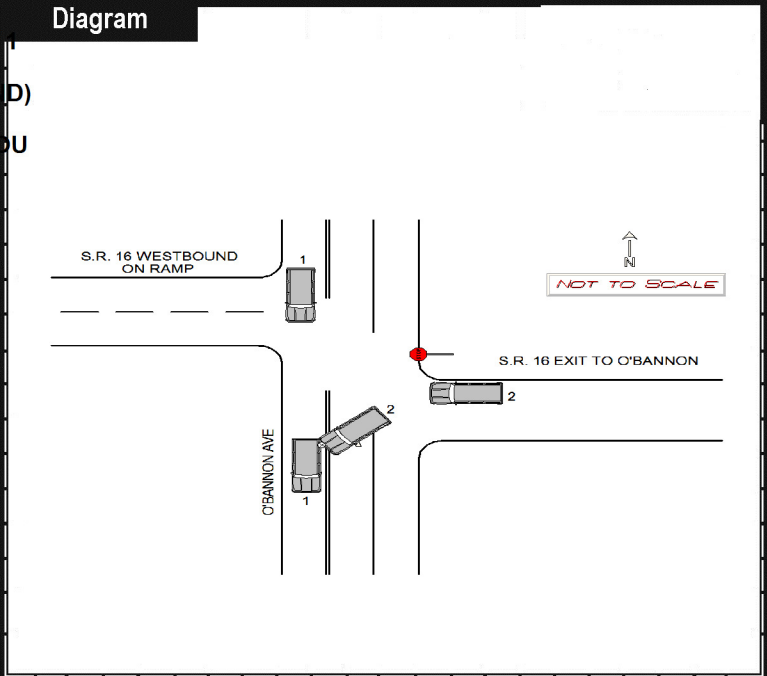

UNIT 2 WAS TRAVELING WESTBOUND ON S.R. 16. UNIT 2 WAS AT THE STOP SIGN OF THE EXIT RAMP OF S.R. 16 AND O'BANNON AVE. UNIT 2 DID NOT SEE UNIT 1. UNIT 2 STRUCK UNIT 1 WHILE ATTEMPTING TO TURN LEFT ONTO O'BANNON AVE.
