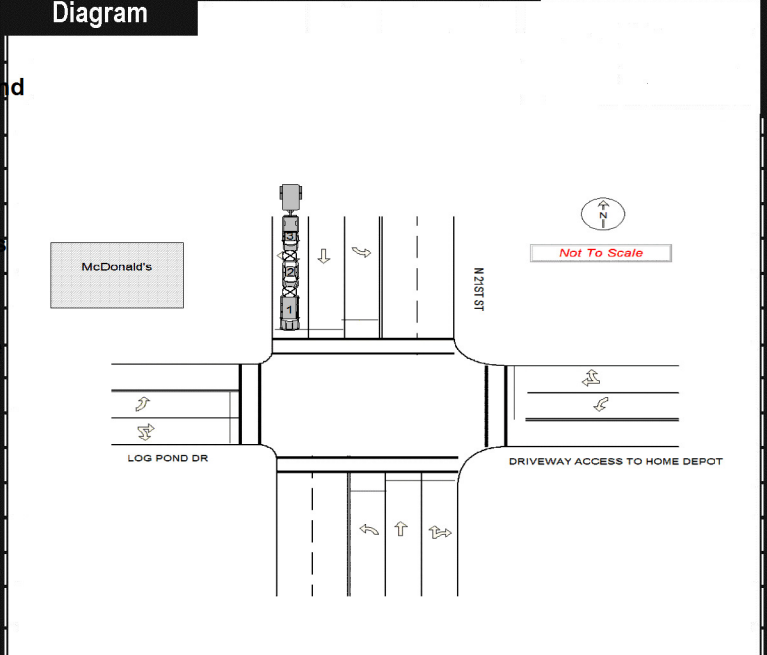

NARRATIVE

Units 1 and 2 were both stopped in traffic, in the right hand lane of southbound traffic, on N. 21st Street, at the intersection of Log Pond Drive. Unit 3 had initially stopped as well behind Unit 2, and reportedly did not realize his foot had come off the brake, and thought the traffic around him was beginning to move, when it was actually him moving. Driver of Unit 3 was pulling a trailer of asphalt, and and stated that the vehicle idles at a high rpm, and he struck the center rear of Unit 2, causing Unit 2 to strike the center rear of Unit 1.
