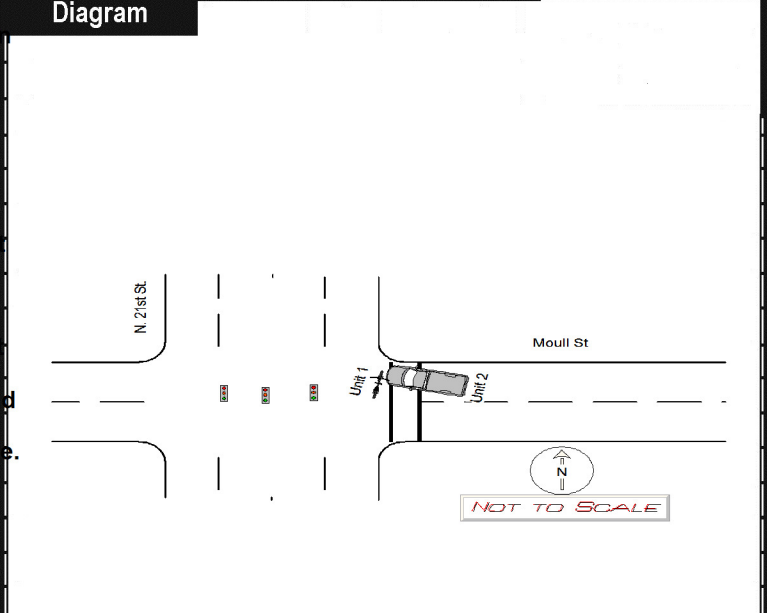

All witness statements indicate that Unit 2 did have a green light and that Unit 1 was in the crosswalk and did not have the right of way. Unit 1 admitted to being in the crosswalk and stated that he wasn't aware of the laws regarding to riding a bicycle.**
