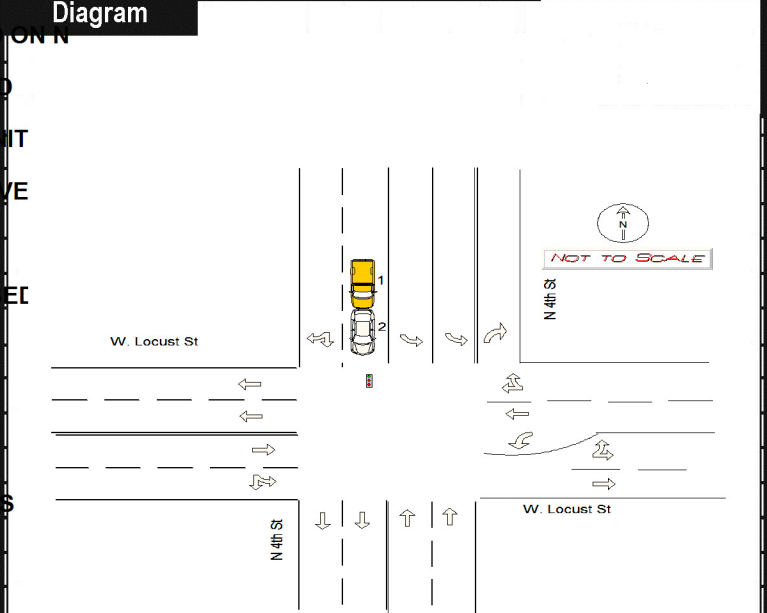

UNIT 2 WAS STOPPED AT THE RED LIGHT HEADED SOUTHBOUND ON N 4TH ST AT W LOCUST ST. UNIT 1 WAS BEHIND UNIT 2 AND FAILED TO STOP IN A TIMELY MANNER CAUSING IT TO COLLIDE WITH UNIT 2. UNIT 2 STATED SHE SPOKE WITH AN OLDER WHITE MALE DRIVER AND ADVISED HIM SHE WAS GOING TO FIND A PLACE TO PULL OVER. UNIT 2 STATED UNIT 1 FOLLOWED BUT CONTINUED PASSES HER WHEN SHE STOPPED. UNIT 1 IS A GOLD 1/2 TON CHEVY TRUCK.

UNIT 2 HAVE MINIMAL DAMAGE (A SMALL SCRATCH). NO INJURIES WERE REPORTED.
