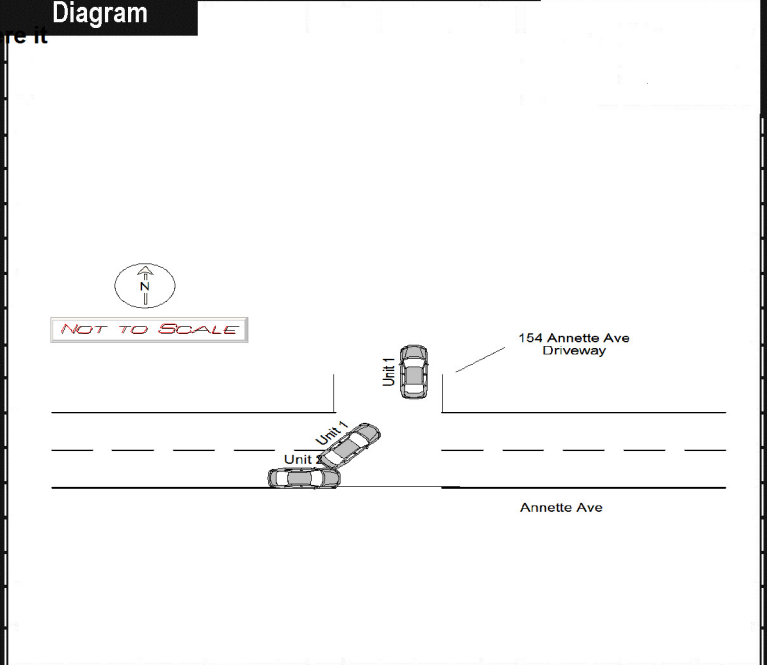

Unit #1 was backing out of the driveway of 154 Annette Avenue where it struck unit #2 that was parked on Annette Avenue.




