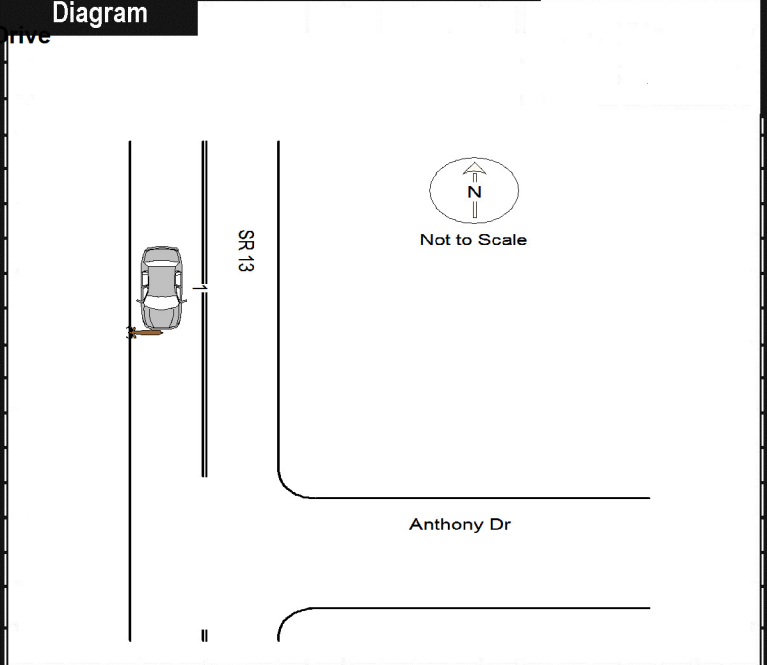

causing damage to the front end.




