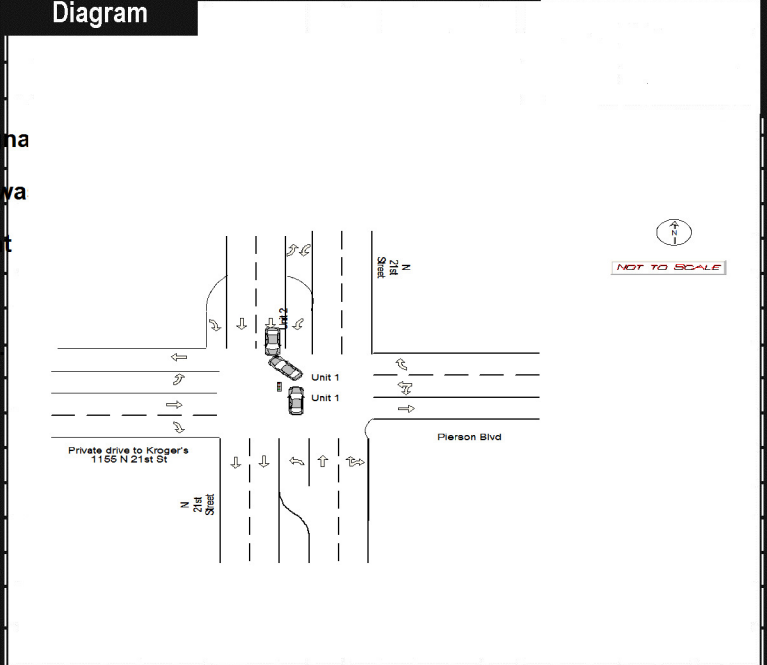

**Unit 1 was in the left turn in the intersection of N 21st Street at Pierson Drive, waiting on traffic to stop to complete the turn. Unit 2 was southbound on N 21st Street and had gotten a red traffic signal. Unit 2 was unable to stop, and entered the intersection as Unit 1 was making the left turn. Witnesses had stopped in the lane to the right of Unit 2, and observed the actions. Unit 2 stated his tires just slid on the wet pavement. Unit 2 cited as Juvenile Traffic Offender.**
