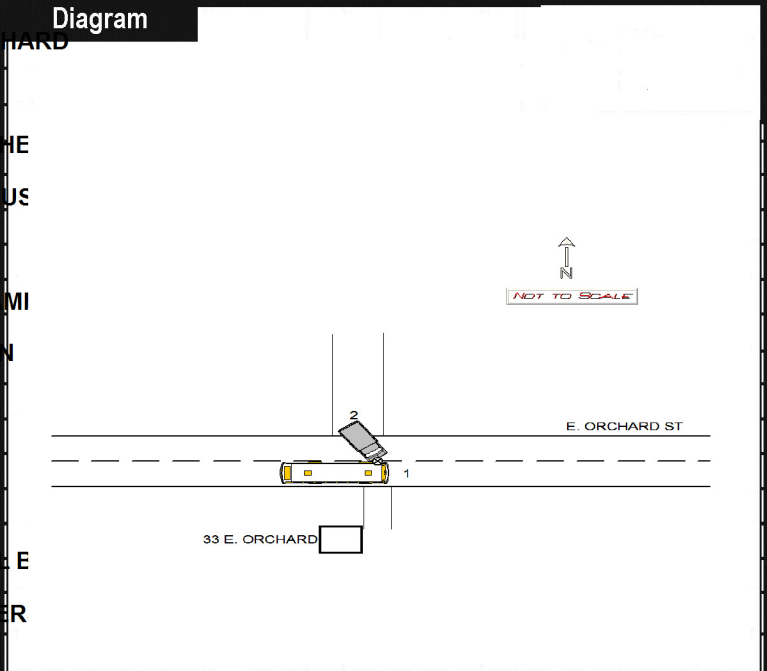

NARRATIVE
UNIT 1 STATED SHE WAS TRAVELING EASTBOUND ON EAST ORCHARD STREET. UNIT 1 STATED UNIT 2 ATTEMPTED TO TURN OUT OF A DRIVEWAY AND STRUCK THE SIDE OF THE BUS. UNIT 2 STATED HE WAS PULLING OUT OF A DRIVEWAY AND DID NOT NOTICE THE BUS DUE TO A TREE IN HIS LINE OF VISION. UNIT 2 STATED HE PULLED OUT AND WHEN HE FINALLY NOTICED THE BUS HE SLAMMED ON HIS BREAKS BUT SLID ON THE ICE AND STRUCK THE BUS ON THE SIDE.
UNIT 1 AND UNIT 2 DID NOT REPORT ANY INJURIES. COULD NOT GET VALID BIRTH DATES FOR THE OCCUPANTS OF THE SCHOOL BUS DUE TO THEM NOT KNOWING THEM. SAME WITH PHONE NUMBER

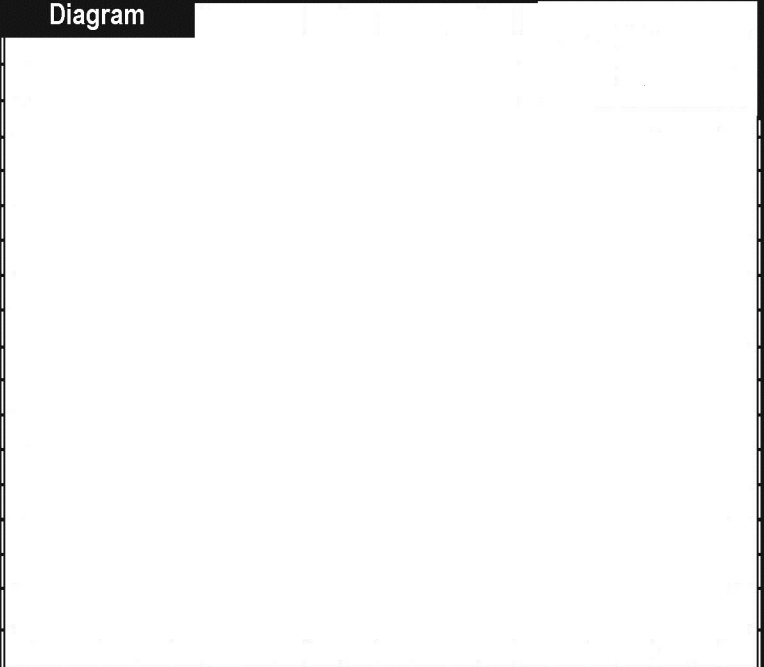


