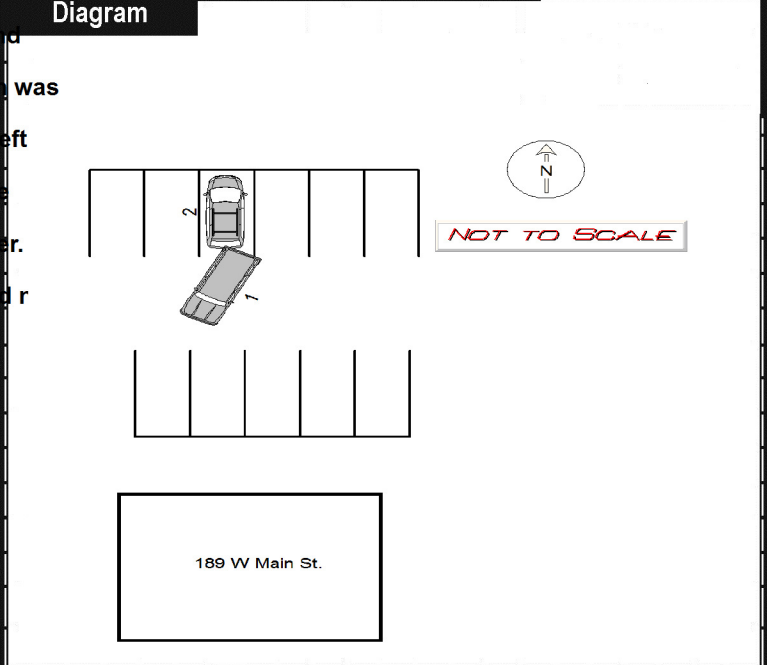

No injuries were recorded.




