



## **URBAN DEER HUNTING PROGRAM**

### **INSTRUCTIONS FOR HUNTERS**

- 1)** Complete and sign application (Make sure it is legible and all applicable spaces and boxes are completed)
- 2)** Complete Proficiency Test at Broken Arrow Archery
- 3)** Sign Hold Harmless Agreement (Must be Notarized)
- 4)** Attach photocopies of Valid Hunting License and Valid Deer Permit  
(Landowners while hunting on their property are exempt from this in accordance with State Law)

All hunters wishing to be part of the lottery to hunt on city owned and controlled property must have their applications completed and returned to the Newark Police Department by **4:00pm on September 9th, 2022** to be considered. Any applications turned in after that date will not be considered for the lottery. You may submit you application after that date for the possibility of being assigned to a property (subject to availability) or if you already have permission to hunt a private property within the City limits.

Reminder, all properties **MUST** be properly registered with the City of Newark and approved prior to hunting on them. It is the responsibility of the hunter to ensure the property they are hunting on has been properly registered and approved for hunting.

A hunters meeting to discuss the regulations and answer questions in reference to hunting the city owned properties will be held on **Wednesday September 14<sup>th</sup> at 6pm**. The results of the lottery draw will be posted at that time.

**CITY OF NEWARK URBAN DEER HUNTING PROGRAM**  
**Release/Hold Harmless/Indemnity Agreement**

The Newark Division of Police regulates, structures and issues permits for participation in the Urban Deer Hunting Management Program (the "Hunting Program") in the City of Newark. Use of firearms is prohibited pursuant to the Hunting Program; only a bow and arrow may be used. Prior to participating in the Hunting Program, each Permittee must execute this Release/Hold Harmless/Indemnity Agreement to protect the City of Newark and participating landowners and lessees from any and all claims for damages of any kind or character related to the Hunting Program. In consideration of being permitted to participate in the Hunting Program, the undersigned Permittee agrees as follows:

1. The undersigned Permittee, his/her spouse, heirs and/or legal representatives hereby releases, waives, holds harmless and forever discharges the City of Newark, the Newark Division of Police, as well as its officers, employees and/or agents, landowners and/or lessees ("Releasees") participating under this Hunting Program, from any and all liability, loss, damage, claim for damage, actions, causes of actions, expenses, costs or attorneys' fees of whatsoever kind or character resulting from the same deriving directly or indirectly from injury or damage to the undersigned Permittee's person or property, including, but not limited to, injury resulting in death to the undersigned Permittee, caused by negligence, acts, omissions or otherwise as a result of the undersigned Permittee's participation in the Hunting Program.
2. The undersigned Permittee agrees to indemnify Releasees from any and all liability, loss, damage, claim for damage, actions, causes of actions, expenses, costs or attorneys' fees of whatsoever kind or character resulting from the same deriving directly or indirectly from injury or damage to the undersigned Permittee's person or property, including, but not limited to, injury resulting in death to the undersigned Permittee, caused by negligence, acts, omissions or otherwise in the course of or as a result of the undersigned Permittee's participation in the Hunting Program. The undersigned Permittee assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence, acts, omissions or otherwise as a result of the undersigned Permittee's participation in the Hunting Program or while in or upon premises where activities under the Hunting Program may lawfully occur.
3. The undersigned Permittee agrees that this Release/Hold Harmless/Indemnity Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Ohio and that if any portion of this Agreement is held invalid, it is agreed that the remainder of the Agreement shall be in full legal force and effect.

The undersigned Permittee hereby declares that he/she has read and understands this Release/Hold Harmless/Indemnity Agreement and further understands that the execution of this Agreement is a condition for eligibility to obtain a deer hunting permit under the Hunting Program.

## 2022-2023 Urban Deer Hunting Lottery

This season we will be having a lottery draw for the city owned/controlled hunting zones. Preference for first choice of hunting zones and week(s) will be given to hunters who have participated in the program previously. This will be for Zones 2 through Zone 6. The season has been broken up into two week increments. Please submit your choices for which two week period you would prefer to hunt and in which zone. We will make every attempt to accommodate one of your first choices but a time slot and zone may be chosen for you at random if your chosen slots are full. Your choices must be submitted with your application. Additional slots will be chosen from those present at the annual hunter meeting on September 9th. Due to the size of the zones, three hunters per 2 week period will be assigned to each zone, except for Zone #5, #6 which will still have the single hunter exemption.

Below is the list of weeks:

Below are the zones and descriptions if you are unfamiliar with them:

**Zone #1: No longer a city hunting zone.**

**Zone #2:** 76 Acres, eastward from the edge of Zone #1 to the treeline west of the Waste Water Treatment Plant on Ecology Row, north of the Licking River and south of the railroad tracks

**Zone #3:** 140 Acres, eastward from the treeline at the edge of Zone #2, to the treeline east of the Waste Water Treatment Plant, north of the Licking River and south of the railroad tracks

**Zone #4:** 78 Acres, eastward from the treeline east of the Waste Water Plant to the edge of the City Limits of Newark, north of the Licking River and south of the railroad tracks.

Zone #5: 22 Acres, West of 21<sup>st</sup> St behind Wal-Mart. Next to NASA soccer fields.

Zone #6: 10 Acres, Southeast corner of Buena Vista Street and Manning Street. Property is on the backside of the Cedar Hill Cemetery.

**Urban Deer Hunting Program**  
**REGULATIONS**  
**2022-2023 Season**

All approved hunters have permission to hunt deer within Newark city limits: **September 24<sup>th</sup>, 2022 through February 5th, 2023** provided the rules and Regulations below are followed. This hunting permission may be revoked at any time without cause on the order of the Mayor, Chief of Police, or their designees. These rules and regulations apply to all hunters and property owners within the city limits of Newark, even while hunting on your own property.

**Proficiency Test:**

1. Hunters must pass an authorized archery proficiency test each year with the weapon they will use to hunt in the City of Newark. The tests will only allow for a maximum of two attempts each year to successfully complete the test. **Shots will be unassisted from a standing position.**
2. The test will consist of 6 consecutive shots into a six (6) inch circle: From a distance of 20 yards. The hunter must score a 100%. Similar proficiency testing from other cities may be accepted at the discretion of the Police Department Hunt Coordinator. These proficiency tests must have been completed within one year of this current hunting season or you must also show proficiency with the City of Newark. **Reminder, all hunters who participated last year must pass a proficiency test each season.**

The Make/Model of the archery equipment used will be documented, including type of arrows used.

3. Pro-Formance Archery, 2984 Mt. Vernon Rd (St Rt. 13) will administer the proficiency test. The cost will be applicable range fees, paid to Pro-Formance Archery at the time of the test. Participants are welcomed and encouraged to remain after the test as the range fee is charged per hour. Please contact them for hours of operation and open range times so as not to conflict with any scheduled events at the business. The employees of Pro-Formance Archery who administer the proficiency test will have the final say as to your proficiency. Other proficiency options may be set up prior to the hunting season at the discretion of the City of Newark.

4. If you change to a different style or brand of bow during the season, you must re-qualify with the new bow before resuming hunting. Changing arrows, broadheads, or any other minor equipment changes do not require a requalification.

## **Regulations:**

1. All hunters are required to have all necessary licenses from the Ohio Department of Natural Resources.
  - a) Prior to final application approval, hunters must possess a valid 2022-2023 hunting license and at least ONE valid deer permit.
2. All hunting laws of the State of Ohio must be followed.
3. Preference will be given to Hunters who work or reside within the geographical limits of the City of Newark.
4. Applicants can have no previous wildlife violations of any kind.
5. Hunters must be at least 18 (eighteen) years of age to apply and participate in the lottery for city owned and controlled properties. Hunters 14 (fourteen) years of age and older may hunt on private properties throughout the city, while accompanied by a non-hunting adult. The non-hunting adult must be with the youth hunter at all times while hunting. Youth hunters must possess a valid State of Ohio hunting license and applicable deer permits unless exempted while hunting on their own property. All youth hunters must have previously passed the State of Ohio Hunter & Trapper Education Course and attach proof at time of application.
6. All hunters must comply with requests/directives given by city personnel while bowhunting on city or county property.
7. All hunters must surrender their name and hunter identification number to any city, state or county personnel upon request.
8. Only bow hunting (long bow or cross bow) will be permitted. State of Ohio requirements for minimum/maximum draw weight will be utilized.
9. When bowhunting within the city limits during the following dates, hunter orange must be worn in accordance with State game laws.

**Youth deer gun: Nov. 19-20, 2022**

**Deer gun: Nov. 28-Dec. 4, 2022**

**Deer Gun: Dec 17<sup>th</sup>-Dec18th, 2022**

**Deer muzzleloader: Jan. 7-10, 2023**

10. No hunting within 200 feet of pedestrian/bicycle paths.
11. When within 200 feet of a residence or occupied structure, shots **must not** be taken in the direction of the residence or structure.
12. **Hunters must harvest 1 (One) antlerless deer, within the city limits of Newark, before they can receive authorization to harvest an antlered deer.** Requirements for antlered and antlerless deer are located in the State of Ohio hunting rules and regulations. "Accidental" antlered deer kills out of sequence will result in the immediate revocation of the hunters permit and subject the hunter to possible criminal prosecution and other state sanctions and penalties.
13. Trail cameras or any other type of photographic equipment for the purpose of patterning of deer are authorized only while hunting on private property and only with permission of the property owner.
14. Bait may be used under the following conditions:
  - Bait sites cannot be permanent
  - Bait sites may not be more than 3ft x 3ft in total area
  - Automatic/timed feeders are authorized only while hunting on private property and only with permission of the property owner. These may only be utilized during the hunting season and are prohibited outside of those dates. Automatic Feeders may not be located within 200 feet of a street or roadway.
  - The bait material may be of any natural food type found regionally
  - The volume of bait on the ground at any hunting site cannot exceed two gallonsThe purpose of a bait site is not to supplement the animal's diet, their purpose is to increase accuracy, to prevent the wounding of animals and increase the harvest rate.
15. Any deer taken within Newark's city limits **MUST** be properly tagged and immediately transported to the Newark Police Department to be checked for count and gender verification prior to any additional State mandated checking procedures.
16. Harvesting of albino or piebald deer is prohibited.
17. Approved hunters will be assigned a number; this number must be present and visible on all arrows used for bowhunting within the City limits of Newark.
18. No parts or remains of harvested deer shall be left uncovered in the field

19. If an arrow is lost or if a deer is injured and unclaimed, please contact Officer Mike Lake, 740-334-0013 immediately to report the incident. Text message is fine.

Hunters found in violation of any of these rules will be subject to having their permission revoked. Also hunters violating the terms of the program may be subjected to criminal prosecution. Any violation of the program rules and regulations will be a violation of hunting within the city limits of Newark 618.20, a first degree misdemeanor. Additional state sanctions and penalties may also apply.

**20. Tree Stands**

- a. All shots must be made from an elevated stand/position toward a deer that is not more than 60yds from the hunter's location.
- b. Elevated stands must be at least Ten (10) feet off the ground.
- c. The elevated stands must be portable with no permanent stands erected.
- d. There can be no screw in steps, with no nails or lag screws driven into trees.
- e. Tree stands can be erected no sooner than one week prior to local season and must be removed no longer than one week after.
- f. Safety restraint systems must be used at all times.
- g. To prevent theft and assist in recovery, all measures to properly mark and identify your hunting equipment should be taken.

Tree Stand Exemption: Due to the amount of theft of hunting equipment in hunting zones 1-4, ground style hunting blinds may be utilized at the hunter's discretion. Ground blinds must be transported into and out of the hunting zones each day. Hunting blinds must be marked with hunter orange of some type. (Nearly all commercial blinds are equipped with hunter orange tabs, if your blind is not equipped with them, hunter orange must be added to make it visible)

The use of ground blinds are prohibited in all other areas of the city.

## Land Owners

Hunting is only allowed on land with written permission from the property owner. All hunting parcels of land must be greater than three (3) acres and must be approved by the Chief of Police, City of Newark Deer Hunt coordinator or his designee.

Property owners of less than three (3) acres may join together, provided that properties being joined are contiguous and not separated by a road and all owners agree in writing that hunting may take place upon their combined properties.

Written permission will be maintained on file by the Newark Police Department and will be updated annually. Certain restrictions may apply to some parcels of land.


The Chief of Police or his designee may approve property less than three (3) acres if safety issues are not a factor.

Property owners must comply with all applicable laws and regulations to permit hunting on their own property and register their property with the Police Department prior to hunting taking place. Property owners may permit, limit, or revoke hunting permission at any time during the approved season.

The leasing/renting of land or exchange of commercial services to persons for the purpose of hunting is strictly prohibited. Landowners or hunters may not profit financially from this hunting program in any way.
