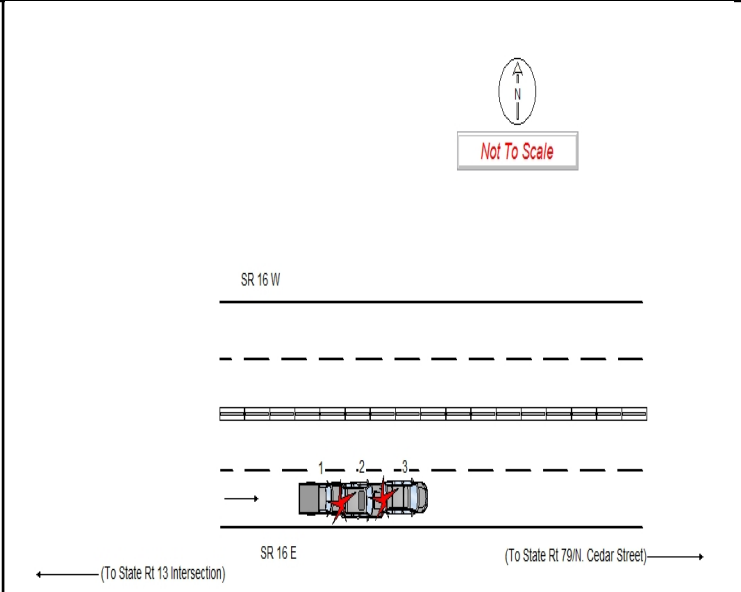

NARRATIVE

10/14/2016, 1455 hours, Unit#03 was traveling east on State Route 16 East and stopped suddenly for traffic near the State Route 16 East intersection with State Route 13. Unit#02 was traveling behind Unit#03 and stopped. Unit#01 was traveling behind Unit#02 and failed to maintain an assured clear distance ahead and struck Unit#02 in the rear. The force of impact sent Unit#02 into the rear of Unit#03. The operator of Unit#02 was transported to the Licking Memorial Hospital by Newark Fire Dept Medics. Unit#01 was a Dodge Dakota with Ohio license plates registered to a Ford truck.
