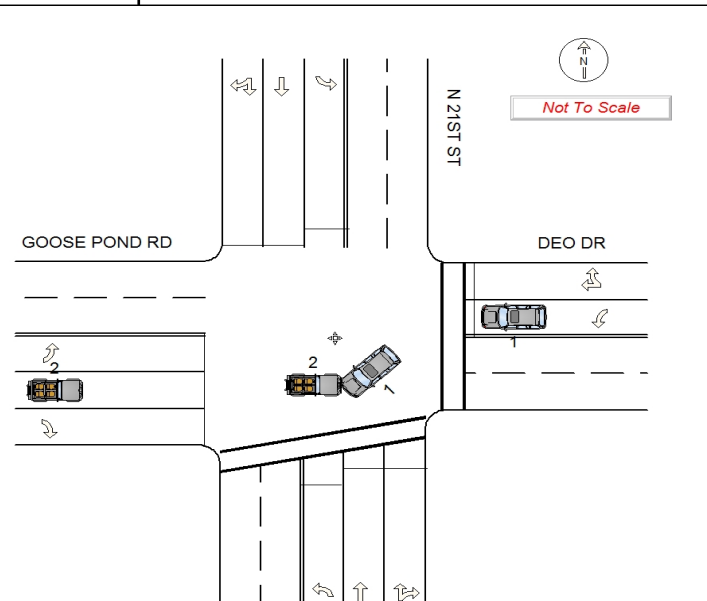

NARRATIVE

Unit 1 was stopped at the red light w/b on Deo Dr. at N. 21st St. in the left turn lane. Unit 2 was e/b on Goosepond Rd. towards N. 21st St. in the center lane. Unit 1 was stopped in the intersection of N. 21st St. waiting for traffic to pass before initiating a left turn onto N. 21st St.

The driver of unit 1 stated that upon the light turning red, she initiated a left turn onto N. 21st St. (s/b) to clear the intersection. The driver of unit 1 stated that unit 2 proceeded into the intersection after the light turned red and she was unable to stop. The driver of unit 1 advised that she heard the sound of the vehicle accelerating prior to the accident.

The driver of unit 2 stated that she was pulling out of Wal-Mart's parking lot onto Goosepond Rd. The driver of unit 2 proceeded e/b on Goosepond Dr. approaching N. 21st St. in the center lane to proceed straight through N. 21st St. onto Deo Dr. The driver of unit 2 stated that the light turned yellow just before entering the intersection and the light remained yellow leading up to losing visual on the traffic light. The driver of unit 2 stated that she observed unit 1 make a left turn and she hit the breaks but was unable to stop.
