NARRATIVE				
The driver of unit 1 stated that she pulled out of the Duke Station, 1073 Mt. Vernon Rd., heading s/b on S.R. 13 (Mt. Vernon Rd). The driver of unit 2 stated that she was traveling n/b on S.R. 13 (Mt. Vernon Rd) approaching the Dollar Tree / Duke Station. The driver of unit 1 stated that she stopped before pulling out onto S.R. 13 heading s/b. Upon arriving at the joint entrance to Dollar Tree / Kohl's / Duke, the driver of unit 1 stated that unit 2 made a left turn onto the stated entrance pulling out in front of her. The driver of unit 1 stated that she was unable to stop in time to avoid the collision. The driver of unit 2 stated that she was traveling n/b on S.R. 13 (Mt. Vernon Rd) approaching the joint entrance to Dollar Tree / Kohl's / Duke. The driver of unit 2 stated that just as she initiated a left turn onto the stated entrance, she observed unit 1 traveling fast out of the Duke Station parking lot onto S.R. 13 (Mt. Vernon Rd) heading s/b. The driver of unit 2 stated that the driver of unit 1 failed to stop before pulling out of the parking lot. The driver of unit 2 stated that unit 1 struck her vehicle before she could clear the intersection. Officer was unable to locate any video from the surrounding businesses or independent witnesses that could corroborate what both drivers advised. The at fault driver is unknown at this time.
