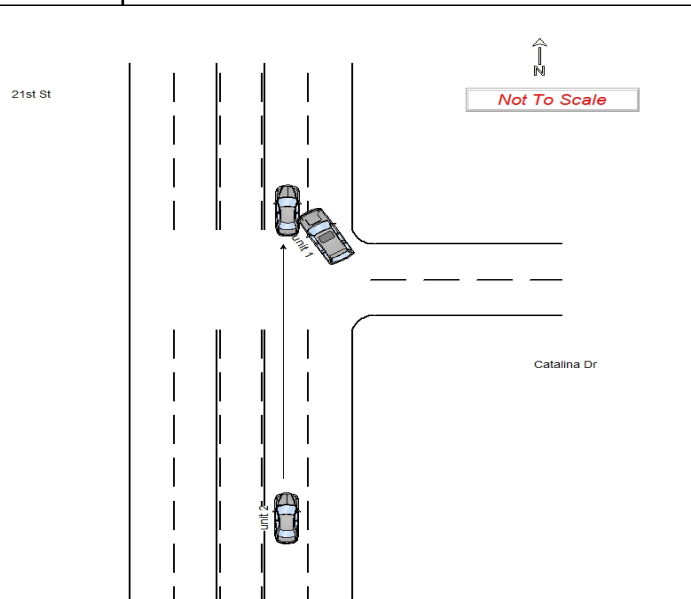

NARRATIVE

On the stated date and time unit 2 was traveling northbound on N 21st St in the center through lane. Upon passing through the intersection of Catalina, unit 1 failed to yield to unit 2 when attempting to turn northbound from Catalina onto N 21st St. Unit 1 did not make the turn into the first lane they continued to the second lane causing a collision. There was minor damage to both vehicles and no reported injuries. Unit 1 fled the scene and came to NPD station. Driver of Unit 1 lied about driving the vehicle stating that the passenger was the driver. Driver eventually confessed and was cited for not having a drivers license as well as failure to yield. Driver of Unit 1 did not have insurance and also wrote a note stating it was her fault.
