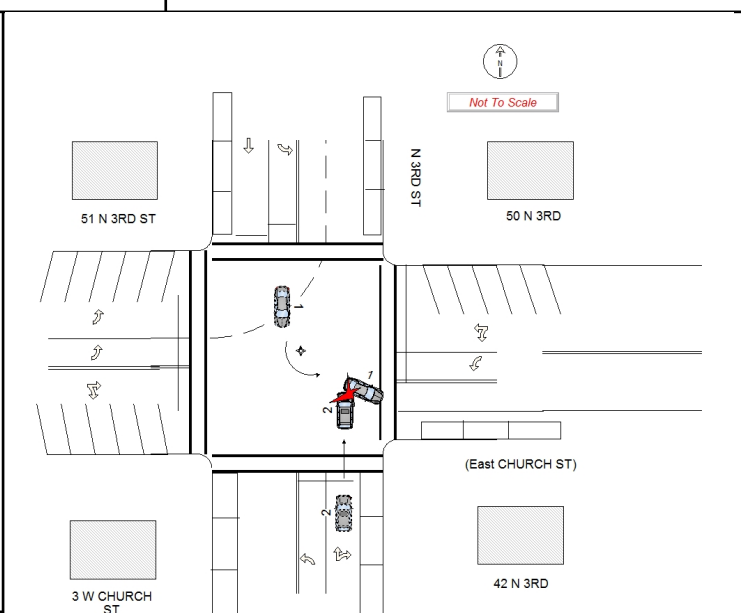

NARRATIVE

12/14/2016, 1509 hours, Unit#01 was traveling south on North 3rd Street. Unit#02 was traveling north on North 3rd Street. Unit#01 made a left turn in front of oncoming Unit#02 and Unit#02 struck Unit#01 in the intersection of East Church Street and North 3rd Street. The operator of Unit#02 reported that she entered the intersection on a green traffic signal. The operator of Unit#01 reported that the left green turn arrow for her direction could have been expired by point of contact of vehicles and that she was confused by Unit#02 "pausing" before continuing forward. Unit#01 failed to yield right of way on a left turn.
