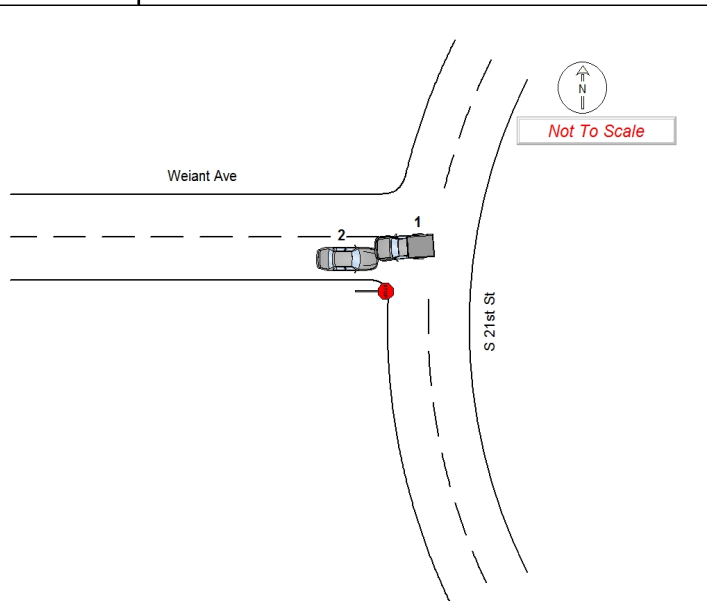
Unit 2 stated Unit 1 was going too fast to make the turn, lost control of his truck (fish tailed it) causing him to enter into Unit 2's lane of travel.

Unit 2 stated he attempted to go get a license plate off of Unit 1 but his vehicle overheated.

Unit 2 stated he immediately dropped his car off at a body shop. When Unit 2 came to file the report he did not have his vehicle with him so no damage was witnessed.

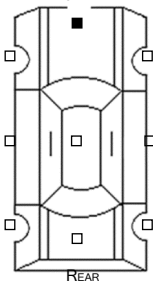
