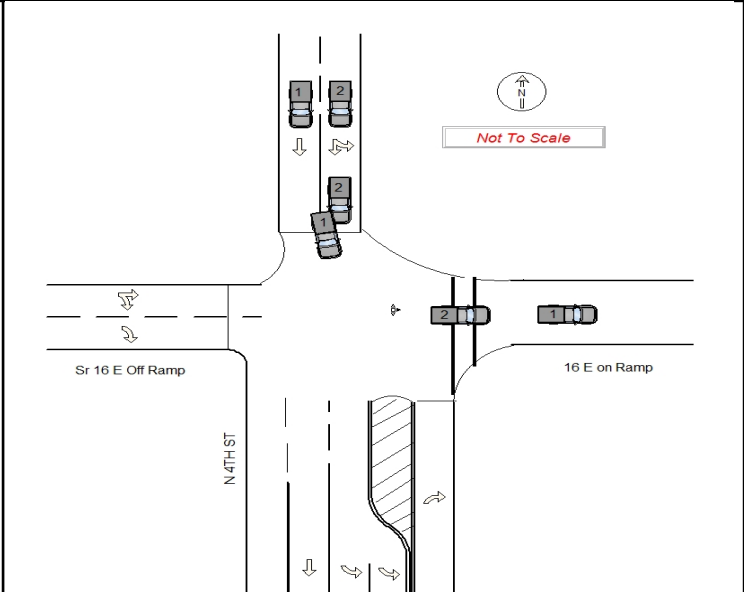

NARRATIVE

Unit#2 stated she was in the left turn lane driving South on North fourth St over State Route sixteen. Unit#2 stated Unit#1 was in the left through lane also traveling South on North fourth Street. Unit#2 stated when she approached the intersection and was preparing to turn left, Unit#2 passed her and turned into her lane striking the right front fender of her vehicle. Unit#2 stated Unit#1 continued to turn onto the on ramp to state route 16 East bound. Unit#2 stated she followed Unit#1 attempting to get Unit#1 to pull over. Unit#2 stated Unit#1 increased his speed and refused to pull off of the road. Unit#2 stated she had contacted the 911 operator and advised them of their locations and of the accident. Unit#2 stated she continued to follow Unit#1 into Nashport on state route 146.

Muskingum County Sheriff deputies stated they spotted Unit#1 and had to drive at high rates of speed to catch up with Unit#1. Muskingum County Deputy stated they were able to stop Unit#1 near the South side of Zanesville, Ohio. Muskingum Deputies cited Unit#1 for violations in their jurisdiction. I met with Muskingum Deputy and the driver of Unit#1. Unit#1 stated he was on fourth St in the city of Newark, Ohio and had entered the East Bound on ramp onto state route 16 from 4th St. Unit#1 stated there was vehicle following him as he drove East on state route 16 but stated he did not remember being in an accident. Unit#1 had an expired license, and was cited for driving with an expired license, leaving the scene of an accident, and lanes of travel.
