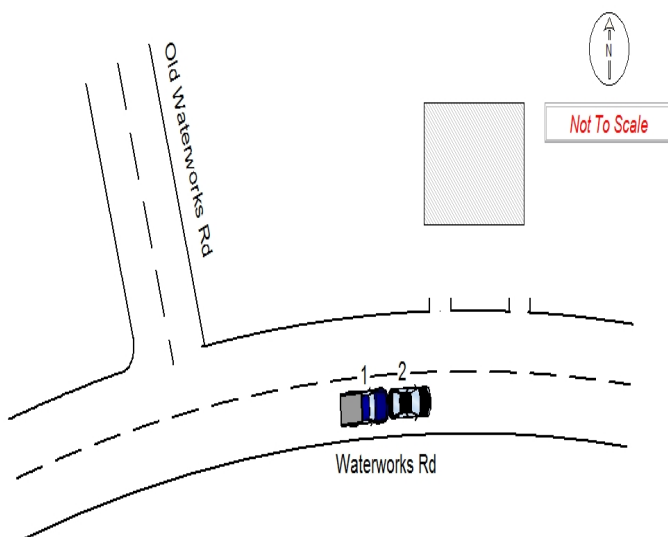
NARRATIVE

Unit 1 was traveling Eastbound on Waterworks Rd just passing Old Waterworks Rd. Unit 2 was also traveling Eastbound on Waterworks Rd and began slowing down to make a turn just passed Old Waterworks Rd. Unit 2 slowed to a stop to wait for traffic to make a left turn. Unit 1 did not see that Unit 2 was stopped and failed to break in enough distance and collided with the back end of Unit 2.

Unit 2 reported possible whiplash and Newark Fire checked her out at the scene. Unit 2 was not transported to the hospital and no other injuries were reported.

Unit 1 was cited for assured clear distance and released on citation.

Unit 1 and Unit 2 had minor damage but were driveable.
