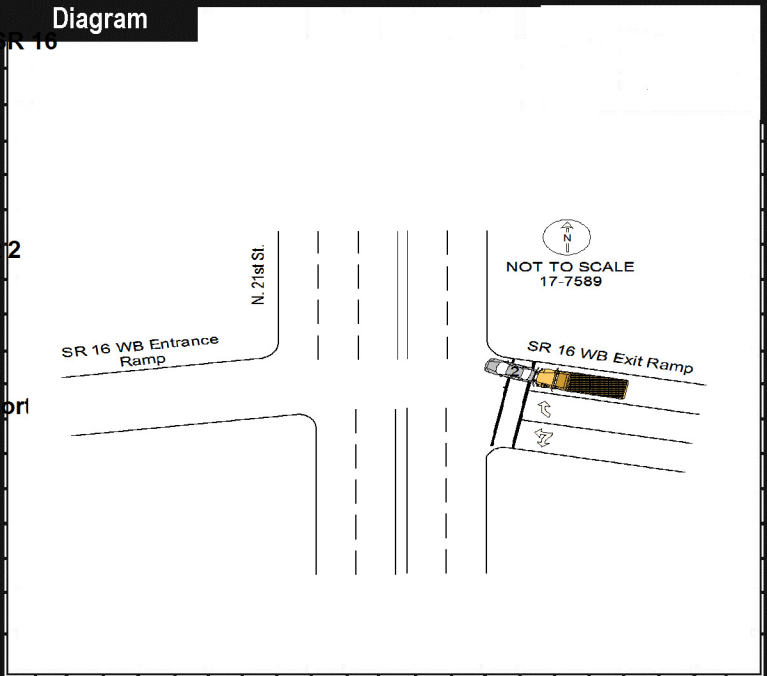

NARRATIVE

Unit 2 was WB on SR 16 exit ramp to N. 21st St. Unit 1 was WB on SR 16 exit ramp to N. 21st St traveling behind Unit 2. Both units were in the right hand lane to turn NB on N. 21st St.. Unit 2 stopped for traffic before turning NB onto N. 21st St. Unit 1 failed to keep assured clear distance ahead and failed to stop. Unit 1 struck unit 2 in the rear causing significant damage to unit 2 with unit 1's front. Both vehicles were still operational upon my arrival. I ordered vehicles to move to a secondary location to conduct the crash report for our and other motorists safety also relieving severe traffic congestion.


