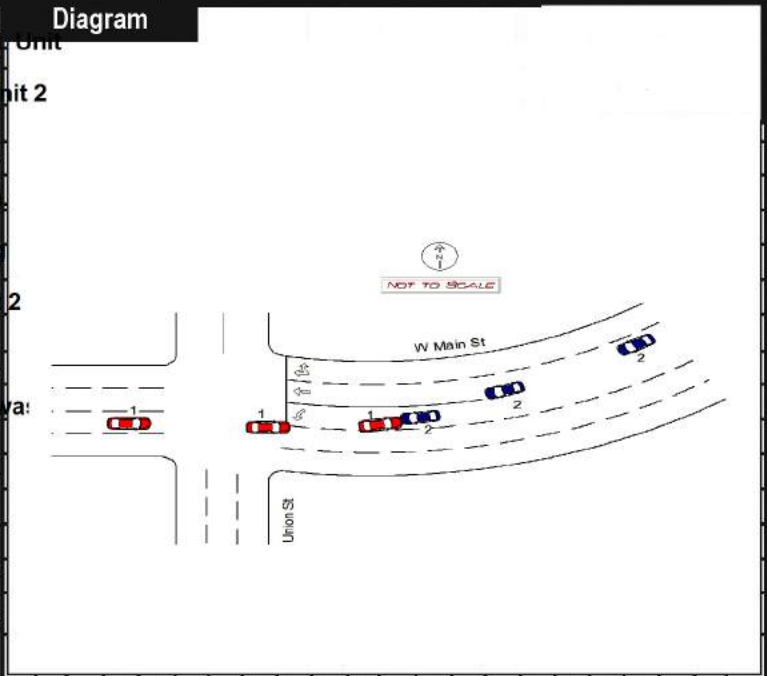

Unit 1 was traveling Eastbound on W Main St approaching Union St. Unit 2 was traveling Westbound on W Main St approaching Union St. Unit 2 entered the left turn lane just before the intersection of W Main St and Union St when Unit 1 went left of center and hit Unit 2 head on. The driver and front seat passenger of Unit 2 were taken to Licking Memorial Hospital by Newark Fire. The backseat passenger of unit 2 minor injuries to his face but was treated at the scene. Unit 1 was impounded and towed to the Newark Impound Lot by M&P. Unit 2 was towed to M&P's lot.

Unit 1 attempted to flee in the vehicle but after he could not get it started he exited the vehicle and fled on foot Northbound from the scene.


