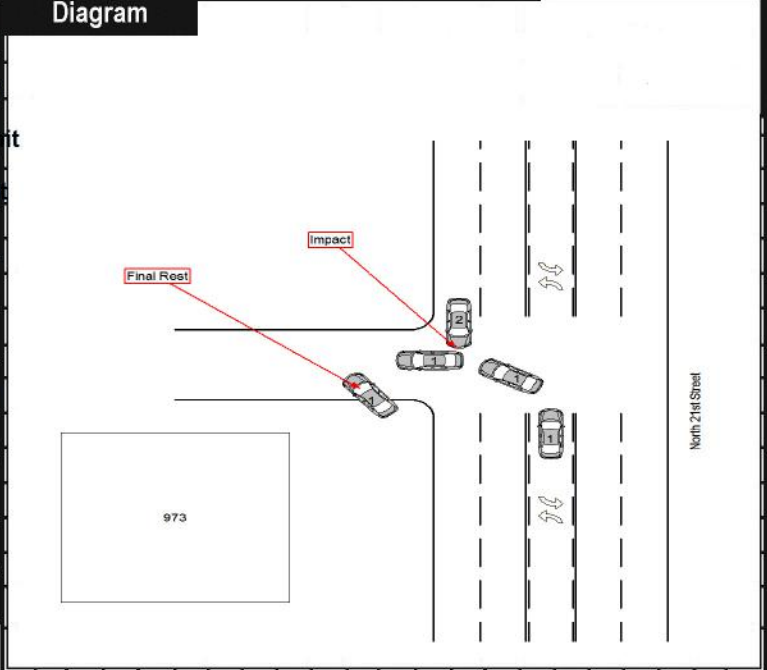

NARRATIVE
