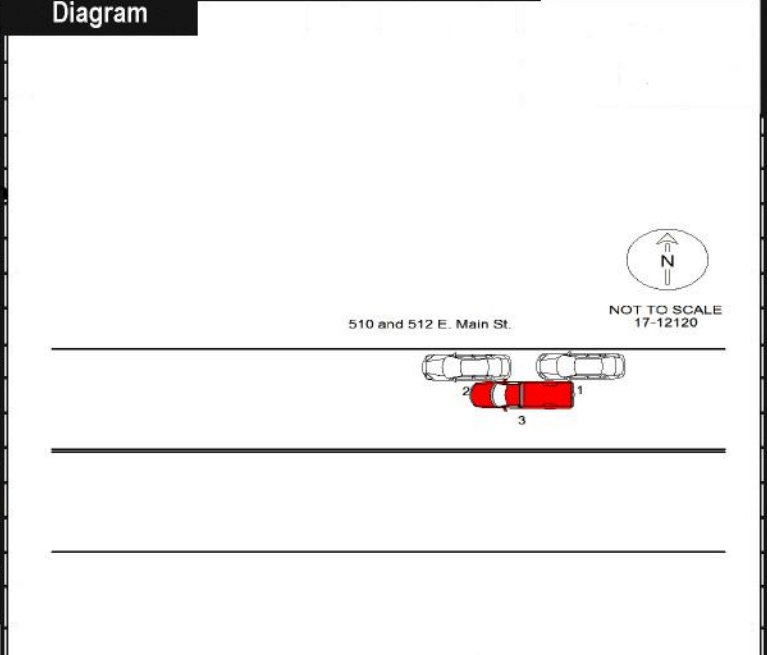
NARRATIVE
